PROCEEDINGS OF WOOD COUNTY BOARD OF SUPERVISORS January 15, 2019 - 9:30 a.m.

The Wood County Board of Supervisors composed of nineteen members convened at the Wood County Boardroom in Wisconsin Rapids, Wisconsin on January 15, 2019.

Vice Chair Rozar called the meeting to order at 9:35 a.m.

Supervisors present were: Ashbeck, Breu, Clendenning, Curry, Feirer, Fischer, Hahn, Hamilton, Hokamp, Holbrook, LaFontaine, Leichtnam, Pliml, Polach, Rozar, Zaleski, and Zurfluh.

Excused were: Machon & Winch.

Vice Chair Rozar appointed Supervisor Pliml as acting Vice Chair for the meeting today. This was confirmed with a motion by Clendenning/Fischer. Motion carried by voice vote.

County Clerk Miner gave the invocation and led the Pledge of Allegiance.

Motion by Hamilton/Breu to approve the minutes of the previous meeting. Motion carried by voice vote.

Motion by Fischer/Leichtnam to approve the appointment of Bonnie Roggenbauer to the ADRC-CW Advisory Committee. Motion carried by voice vote.

Public Comments: Michelle Boernke, Campus Administrator of UW-Stevens Point at Marshfield provided the board with a report of current programs being offered at the campus. There was extensive public comment regarding the resolution placing an advisory referendum on the ballot concerning legalizing marijuana, being acted on at this meeting. Discussion revolved around the various impacts of legalization and the process used to bring the resolution forward.

Long term employees were recognized and received a plaque for their years of service by their respective department heads.

Referrals were noted.

Without objection, Vice Chair Rozar moved Item 5-2 up in the packet.

RESOLUTION 19-1-1

Introduced by: Judicial & Legislative Committee

INTENT & SYNOPSIS: To authorize two advisory referendum questions on the April 2, 2019, ballot to measure public opinion in Wood County as to permitting the use of medical marijuana as well as to legalize its use for adults 21 and over.

FISCAL NOTE: The estimated cost to add this referendum to the ballot is less than \$1,000, which will cover printing, programming, and other election related activities.

Motion by Clendenning/Breu to adopt Resolution 19-1-1. Motion Curry/Fischer to refer this resolution to the Health & Human Services and Public Safety Committees for further study. Vice Chair Rozar turned the gavel over to Acting Vice Chair Pliml. Discussion ensued regarding timelines, process and the effects of an advisory referendum. Motion to refer failed. Voting no were LaFontaine, Feirer, Ashbeck, Hahn, Holbrook, Hokamp,

Clendenning, Hamilton, and Leichtnam. Excused were Machon & Winch. Lengthy discussion ensued. Motion by Holbrook/Leichtnam to amend Resolution 19-1-1 to eliminate from the first referendum question listed on the resolution "...and medical use, which will...." and to have the question read "Should marijuana be legal for adults, 21 years of age and older, for recreational use to be taxed and regulated like alcohol?", and further, to reverse the order the questions appear on the ballot as compared to the resolution. Lengthy discussion ensued. Motion to amend carried. Voting no were Zaleski, Fischer, Breu, and Zurfluh. Excused were Machon & Winch. Motion to adopt amended Resolution 19-1-1 carried. Voting no were Zaleski, Fischer, Breu, Hokamp, Polach, Pliml & Zurfluh. Excused were Machon & Winch.

Vice Chair Rozar assumed the gavel and called for a recess at 10:55 a.m., reconvening the meeting at 11:05 a.m.

Supervisor Hokamp was excused.
