Steve stated PPE is still ongoing with approximately 170 facilities being supplied. Orders from entities are going up as the cases in the County increase. Talked about the testing at Hilltop Grand Village and the Jail this week by the National Guard. Talked about the community testing event on Wednesday with the National Guard at Lincoln High School.

10. Sheriff's Department:

a. Correspondences:

Sheriff Becker stated he is currently working with Lori Heideman and Anthony Bastien with regard to Fail to Pay Warrants. The Department is examining the possibility of having them sent to collections as opposed to being entered for apprehension. He said this would save jail bed space and would also save the County money. Sheriff Becker said most counties are already doing this. He stated he will present the findings to the Judges and Clerk of Courts next month.

Sheriff Becker stated the Jail's body scanner, which was acquired through the CARES Grant, will arrive sometime during the week of August 17, 2020.

Sheriff Becker stated COVID-19 testing for inmates and employees will be conducted tomorrow, August 11, 2020, at 12:30 p.m. He stated the Department is working with the Health Department and the National Guard to facilitate the testing

Sheriff Becker addressed the mask mandate. He stated the Department is not enforcing the mandate; however the Department is working with the Health Department if they need assistance. He stated he has been working with Emergency Management to get masks in the squad cars for the deputies to hand out to those who need them.

d. K-9 Project:

The Committee reviewed the K-9 report.

Sheriff Becker stated the Department has added a new K9. He stated Deputy Justus Arendt and K9 Timo will begin training next month. He said the Department will make a decision next week whether or not to add a fourth K9.

Sheriff Becker stated the Department has hired two new deputies and will be talking with the Civil Service commission to establish a new eligibility list later this year.
