1. Call meeting to order. Meeting called to order at 8:00 am,

Public comments. Kay Bassuener, lives near SWC Park and was recently issued a citation from one of the employees for not leashing her dog while in the park. C. Schooley invited her to speak on how she felt about the dog ordinance as well as the citation she received.

Mrs. Bassuener states that she uses this park daily and has for many years. She is aware of the pet ordinance and has had many conversations with the Director, C. Schooley regarding it. She believes the ordinance does have good merit behind it, but does not feel as though it was properly dealt well with just a few days ago. She feels the park should continue to be a user-friendly place where there is peace and harmony, but she no longer feels this is the case, Mrs. Bassuener feels as though discretion should be made by park staff on which dogs need to be leashed and which ones are under control. Mrs. Bassuener feels the new employee who issued her the citation was rude to her. The employee wrote her a ticket and placed it on her vehicle. She felt the ticket was crumpled and scribbled out and not legible. Mrs. Bassuener felt it should have been handed to her directly rather than left on her car as a way to avoid confrontation.

Mrs. Bassuener's husband Craig Bassuener introduced himself. He wanted to know how the Ordinance is enforced, and who enforces it and when? Mr. Bassuener also said he believes this citation is retaliation and harassment. He believes that the citations need to be issued fairly and equally to all violators, if we plan on enforcing it.

Mrs. Bassuener also asked if it was possible to have the park trail plowed during the winter so people can use it during this time for walking, running, etc. C. Schooley stated they do not plow the four mile trail around the lake except for areas for wood cutting and other maintenance reasons. They do typically maintain the stretch from White Sands Beach down to the dam. During the end of this last winter, they did plow from White Sands Beach to 64th Street. They are not set up to salt and sand and do not have the staff or resources to do this. They also do not have a salt/sand spreader so it would need to be done by hand. C. Schooley

is willing to try and keep that section open in the winter time but it may not be salted or sanded, and will only get plowed when sufficient manpower and time is available.

Mr. Miner stated we are only hearing one side of the story but it appears there are some customer service issues here and those will be addressed within the department. Miner stated perhaps we need to do some customer service training with our employees to avoid this in the future.

C. Schooley stated there is a lot of frustration from residents who walk in the park that they are constantly stepping on dog feces. It was mentioned that receptacles could be available to clean and pick up after pets and it was agreed to be a great idea. C. Schooley will look into purchasing receptacles for the park(s).

Mr. Polach stated it definitely could have been handled in a better fashion and this will be addressed. Mrs. Bassuener requested to consider having the citation torn up as we have made our point and she will make sure her dog is on the leash from this point forward until at some point in time, this can be addressed further.

ATV use/trails. Three individuals were at the meeting regarding the ATV trails. Jeff Masephol, Tom Nelson and Jerry Masephol. These individuals are concerned about the state of our ATV trail in Wood County. They stated we should take better care of this park and put more money into it. F. Schubert states it's just the nature of where the park is. The area does not drain well due to the soils and high water table, and so when one person drives through, it makes a rut. They are also here to find out how to go about creating more ATV trails in Wood County.

A lengthy discussion took place on how to proceed. The next Town's Association Meeting is Friday, April 15<sup>th</sup> in the Township of Rock at 7:30 pm. It was discussed that someone from this committee should represent and let them know we are willing to consider opening parts of County land and possibly sections of road if we can accomplish this in a safe manner. Who would this person be? The committee is aware of the economic possibilities this could open up for Wood County. L. Pliml feels we are losing thousands of dollars in potential revenue that ATV trails could bring to the county. Wood County might need to take the lead at a Town's Association meeting and be a part of the discussion. It was discussed that there should be a HIRC representative at the meeting.

This should be placed on the agenda at some point when we have the Township Representatives present. The first thing that needs to be done is take the current map down to Planning & Zoning and have a new map created showing the updated Town routes and proposed County Highway routes.

Approve minutes of the March 3, 2016 and March 15, 2016 Highway, Infrastructure, and Recreation Committee meeting(s) and the WCWAAC Minutes from January 26, 2016.

B. Winch had a comment regarding the March 3<sup>rd</sup>, HIRC Minutes. He didn't feel that one of the comments in comments in the minutes, made by a constituent, was accurate.

  - C. Schooley was asked to attend a meeting in Necedah regarding the Dexter Dam to explain how the Park and Forestry Department controls it. There has been a lot more flooding this year due to the saturated soils and increased precipitation.

The meeting on Monday, April 25<sup>th</sup> at 1:00 pm in Necedah regarding dams. Joe Behlen from the DNR will be there and oversees all the dams in this area. The exact meeting location is TBD. Shane W. from Planning & Zoning stated when you attend that meeting keep in mind the dam is not designed as a flood control structure. The capacity is not there in that dam to manage flooding events. It was never designed as a flood control structure.

7. Approve payment of bills.

8. Discuss and possibly act on MOU with Land and Conservation for Forestry Shop use. Shane and Doug reviewed and explained the MOU. The insurance for the building will be provided by Land Conservation. It has been used by them for over 30 years and they assumed the repair and maintenance on it.

Polach stated he hopes all will share the space as needed in the future regarding bikes, trees, and forestry equipment.

Motion to approve the MOU by Miner and instruct the supervisor to sign it after the correct date has been placed on the paper. Seconded by Hokamp. Voting yes, Hokamp, Breu, Winch, Miner. Voting no, Polach. Polach's reasons for voting no are he feels the space should solely be used for the Highway Department and allow Land and Water Conservation to utilize that space only when needed.

9. Discuss and possibly act on bid for crushing at the pit. D. Passineau handed out the bids that were received.

Motion to accept the bid most advantageous to Wood County for crushing at the pit. Miner/Hokamp. MC

- 10. Discuss and possibly act on Quad Axle Haul Truck bid. Bid information was handed out to the committee and explained to them by D. Passineau. Motion to approve the bids and move forward with the one which is most advantageous for Wood County, Miner/Polach. MC
- 11. Open and possibly act on quotes for CTH N bridge painting. Bid information was handed out to the committee and explained by D. Passineau. Motion to approve the highest bid or whichever is most advantageous for Wood County. Miner / Hokamp. MC
- 12. Discuss METCO groundwater monitoring. D. Passineau stated that when the Highway Department removed the pumps and tanks, preliminary testing indicated there was some soil contamination. To determine the area that needs to be dug out and the soil removed, test wells will be drilled.
- 13. Discuss Cold-In-Place Recycling (CIR).

  That is going to be done on County Trunk V. This is a new process in WI. They pulverize and inject oil into the gravel and lay it back down with a paver. It's supposed to be just as strong as or stronger than putting 3-4" of asphalt on and a large savings to the County. This is scheduled for some time in July.

- 14. Discuss CTH T Bridge. D. Passineau discussed moving forward with the contractor. Motion by Miner and seconded by Hokamp to approve Jewell Engineering bid of \$39,500. MC
- 15. Discuss 50/50 Bridge Program funding. Discussed.
- 16. Discuss electronic time keeping. The Highway Department has chosen to go with their own program called "RTVisions". They can punch their time in on a smart phone or computer. No problems are anticipated and all time will be approved online by a supervisor.
- 17. Discuss personnel issues. The Highway Department lost two good employees recently to the City of Wisconsin Rapids. We need to find better ways to keep our employees. A very lengthy discussion was held here regarding steps, pay increases, grades, etc. L. Pliml stated we constantly look at steps and grades and we move forward. Everyone on the committee would like to see this placed on the Department Head meeting agenda for further discussion.
