- 1. Call meeting to order.

Supervisor Fischer thanked Supervisor Hokamp for her many years of service on the County Board and on the Highway oversight committee. Hokamp was first elected to the Board in 1994 and served on the Highway oversight committee (and later the Highway Infrastructure and Recreation Committee) from 1994-1998, 2004-2006, and again from 2008 to the present. The committee thanked her for her service.

R. Hawk stated that weight limits came off today. In addition, he received a letter stating that the frac sand company Carbo Ceramics had filed for Chapter 11 bankruptcy. Hawk stated the Highway Department has no outstanding balance with them since they received money up front for the improvement of the road.

Hawk also stated that they interviewed one person for and LTE Truck Operator position and the person did not accept the position. He is hoping to hire 4 Summer Help instead.

5. CONSENT AGENDA

- a. Approve minutes from previous committee meetings.
- b. Department Staff Reports

Motion by D. Polach and second by M. Hokamp to approve the consent agenda items less pages 3 and 6-19. All in favor. Motion carried.

6. Review items, if any, pulled from consent agenda

The committee reviewed the pages in question. Winch requested additional information on numerous vouchers presented by both the Highway department and the Parks and Forestry department.

Motion by L. Pliml and second by D. Polach to approve the removed pages from the consent agenda. All in favor. Motion carried.

7. ATV Update

No ATV update was provided. Hawk stated he would have a few sections of County Highway for the committee to review for the purposes of opening for ATV use. He will have these on the May agenda.

8. HIGHWAY

a. GSB 88 Bid Results

Hawk stated both bids received were lower than he had expected. This will allow them to do more of these types of projects than previously planned. Gee Asphalt was the higher bidder with Fahrner Asphalt getting the low bid. Hawk stated that, as discussed at the March meeting, he would like to split the projects between the two bidders so he could test both of their products, as Gee Asphalt had indicated that they had some proprietary method that they claim will produce better results.

Jeff Schuh from Fahrner Asphalt expressed disappointment in the idea of splitting the projects between the two bidders. Hawk explained that the oversight committee already approved that.

Motion by L. Pliml and second by W. Winch to accept the bids and uphold the recommendation made in March to offer projects to both bidders. All in favor. Motion carried.

b. Chip Sealing Maintenance Plan

Hawk shared the chip sealing maintenance plan with the committee. He stated that the asphalt industry is recommending reconditioning of pavements as soon as 1 to 2 years after reconstruction. Hawk stated the Highway department is doing 3-5 years for treatments.

c. 2021 Capital Improvement Projects Bonding

Hawk shared correspondence from the Wisconsin Department of Transportation regarding the rebuilding of the salt sheds in Marshfield. They agreed to reimburse the County for construction of a State salt shed when built at the same time as the County salt shed. Hawk stated he would like a portion of the 2021 capital bonding to be used for the salt shed construction. He is estimating \$350,000 approximately for the site work, foundation, and shed. The State would fund their sister shed through the Routine Maintenance Agreement (RMA) reimbursement. Hawk stated he would be overall lowering the bod amount to \$2 million for 2021, including the \$350,000 for the salt shed, but will end up covering the same amount of construction work as expected previously due to grant funding.

Motion by M. Hokamp and second by W. Winch to approve the 2021 capital bonding recommendation provided by the Highway Commissioner. All in favor. Motion carried.

- d. County and State Funded Salt Shed Project This topic was discussed in conjunction with item 8.c.
- e. Discussion of March future agenda items:

71st Street Culvert – Supervisor Clendenning requested this be an agenda item. Hawk stated that the culvert at the intersection of CTH W and 71st Street has not failed officially, but is undersized. Hawk stated they do plan to replace this eventually. Clendenning stated that he has been researching this culvert for years and cannot find record of it being approved. Hawk stated that nutrient flow issues are not the Highway department's responsibility and that they are responsible for maintaining drainage of the roadway. C. Schooley stated that in prior years, they would never see water flowing on the park property but they have had a constant stream flow this year and it is disrupting use of the walking trail.

Study of County Truck U – Hawk stated that the Town of Grand Rapids had applied for grant funding for a project through the State MLS (Multimodal Local Supplement) program for Washington Ave. This was not approved. A cranberry producer owns the parcel that the road is being redesigned for, but the parcel has been annexed into the City of Wisconsin Rapids. Hawk believes that the issue is between the Township and the City and any improvements made to the roads should have the City included on the conversation.

9. PARKS AND FORESTRY

a. Public service announcement/commercial for logging and snowmobile trail safety

F. Schubert stated that he had sent out an email with a video attached for the committee to discuss. The video is a Public Service Announcement encouraging safety around logging operations for snowmobilers and the like. Shubert stated that the Wisconsin County Forestry Association and the Great Lakes Timber Professionals Association had funded the video and are now asking counties if they would be willing to contribute any funds to distribute the PSA. They produced the video last year, but Schubert did not ask at that time because funding was so tight.

Fischer asked if the funding would come out of the Parks and Forestry Budget. Schooley stated they have a small line item for advertising and promotions, but that it could maybe be absorbed into the budget. Schooley stated the PSA is already out and running on many platforms – this effort would just extend its reach.

Pliml stated he would be willing to bring the matter to the Wisconsin Counties Association to see if they would be willing to fund it at all, given that it is a matter that affects all counties. Motion made by L. Pliml to allocate \$1000 in the Parks and Forestry budget for the PSA but to wait to pay until it is determined what involvement Wisconsin Counties Association will have. No second. Motion dies.

The committee agreed to wait to hear from Pliml on the WCA involvement before taking further action and asked that this topic be put on the May agenda.

b. Discuss concerns from Wood County townships.

Schooley shared a draft agreement between the Parks and Forestry Department, Highway Department, and the Towns regarding debris cleanup in County property right of way. Schooley stated he has not heard back from Jim Patrick, the township representative he was working with on the matter. Clendenning suggested that Patrick take the matter to the Towns Association to get a collective approval. It was suggested that Schooley discuss the matter with Jim Tremelling who is the head of the Towns Association in Wood County.

c. Forestry 15-year plan, Chapter 500 and discussion of notes.

Schubert stated that the only section in Chapter 500 that is not complete is section 525, which discusses Treaty Rights. Tribal involvement has changed on a number of the County forestlands and so this section will need to be revised extensively and brought back for review later.

d. 2021-2025 CIP

Schooley stated he was looking for insight from the committee on their capital improvement projects list as a lot of it depends on if they have the support of the committee or the board for funding of the Powers Bluff project. Fischer stated that because committees will likely be reorganized after the elections, he thought it would be prudent for the new committee to provide their insight before approving the capital improvement projects. There was committee consensus to wait to approve the Parks and Forestry CIP until after the new committee is formulated. It will be put on the May agenda again.

e. Parks Revenue Report

Schooley stated the Parks and Forestry Revenue Reports were able to be included in the consent agenda this month because of the late committee meeting date. Schooley did share that they had a number of shelter reservations cancel because of the COVID-19 restrictions but that camping has not seen many cancellations yet.

Motion by W. Winch and second by D. Polach to approve both the presented resolutions. All in favor. Motion carried.

Subject: Commissioner Report for May 7, 2020 HIRC meeting

Department Activities

Personnel

Department staff are required to follow the social distancing directive from Governor Ever's Safer at Home order. Highway Department has a plan for limiting exposure for our staff in order to maintain a healthy work place while we ensure there are sufficient staffing required for winter and maintenance operations.

Department has completed web or conference call interviews for mechanic and accounting technician positions. Reference checks are being completed and offers should be sent by 5-7-20.

Highway Projects

CTH U (STH 54 – South Biron Drive) STP Urban project started April 20 and is scheduled to be completed in late September. The Highway Department has set up temporary mailboxes for residents while the construction project makes it difficult for mail carriers to access individual residents. Weekly updates are being posted on the WCH web site.

Work on 2020 construction projects is slated to begin in later part of May. Initial projects are CTH Y between CTH V and City of Marshfield and CTH V from STH 10 to Yellow River Bridge. Three bridge replacements are scheduled to begin after June 15.

Highway Commissioner has negotiated with WisDOT to provide funding to replace deficient state salt shed at the Marshfield facility in 2020-2021 FY. WisDOT has provided an offer to use unused RMA funds from 2019-2020 contracts for Wood County forces to replace aged/undersized state salt shed. This work would be done in conjunction with Wood County replacing aged/deficient/under-sized County salt shed in 2021. HIRC approval to use bonded 2021Capital Improvement Funds funds in the amount of \$350,000 to construct a County 2500 Ton Salt Shed at the Marshfield facility. HIRC approved constructing a county shed in 2019 but the funding source was not defined. With the State MLS grant and potential Ho-Chunk BIA Roads division grant for CTH X the Highway Department would limit the total Bonded Capital Improvement funds for 2021 to \$2,000,000 for highway improvement funds.

Highway Maintenance

Patrol Superintendents are preparing for 2020 construction projects. Crews are grading ditches, cutting trees & brush from the right-of-way, performing bridge repairs, and replacing culverts where possible.

Crews are patching holes, filling cracks, and placing mastic on spots where pavements have been damaged over the winter.

The Highway Department performs chip seal projects during the first two weeks in June. This year a process new to Wood County is being performed as an alternate to chip seal, and it is referred to as GSB88. Bids were received in April for this work and two contractors will be used to perform this maintenance procedure. This work is not currently scheduled but is expected to take place in late-June or July.

ATV Plan

HIRC has directed the Commissioner to review the approved ATV County Highway Routes in May. Included in the packet is a map showing approved routes and proposed routes, in addition there is a map showing the Wood County ATV Route Trail System.

Commissioner has received a request to evaluate CTH AA from CTH G to Lynn Hill Road and CTH X from STH 80 to STH 54 for ATV access. The Commissioner is in favor of approving these segments of County Highway open to ATV/UTV access.

On Line Permitting

Department is working with RTV ision to implement on-line permitting. Anticipate segments go live in 2020, with recent work place restrictions due to Covid-19, this will be delayed until later in 2020.

Access/Driveway Policy / Fees approved November 7, 2019 HIRC. (This policy & fee structure is available on line at the Wood County Highway Web site.

Fee revisions approved March 12, 2020 HIRC:

Seasonal Truck Weight Restriction Permit (new) \$300, \$400, single trip, double for multi-trip up to 3x Utility Permit increase \$25 - \$50 Boring fee increase to \$100 Open Cut Fee increase to \$500 plus \$35 per additional 1000 feet

Oversize/Overweight increase from \$25 - \$50 Over Height/Over Length increase from \$25 - \$50

Wisconsin County Highway Association (WCHA)

Commissioner was elected to Secretary in January, he will serve in this position for two years then assume the President role for two years, and then move to the Past President position for two years. There are opportunities for elected County Board members to serve on the WCHA Executive committee. Currently the Vice Chair position is open and nominations are being accepted.

WCHA Summer Road School scheduled for June 1-3 at Chula Vista in Wisconsin Dells has been rescheduled for August 10 - 12. This is an opportunity for county highway staff and committee members to receive education and training regarding county highway business.

Director Report, by Chad Schooley

- COVID-19 response. Our most recent News Release is included in the packet. I have been working with staff on developing signage and operational changes as we navigate through this process. I continue communicating with other professionals in the field on how they are operating under "Safer at Home" orders.
- I have asked James Patrick, Chairman for Town of Cary, to forward the Right Of Way Agreement, which was drafted with input from a number of townships, to the entire Wood County Town's Association for review. I will forward followup information once I receive it.
- I have included the 5yr CIP summary sheet. I would like to discuss this in more detail at the meeting.
- Finalized 3-yr contract extensions for garbage/recycling in all parks, and mowing at South Park/Nepco.
- Assisted in meetings with Campground staff/volunteers to discuss COVID-19 restrictions, and overview of job duties/expectations.
- Special Use Permits
 - Northward Peddle and Paddle has requested providing canoe/kayak rentals at Lake Wazeecha this summer. They would like to keep an equipment trailer on-site at Portage Point, which is the far North East corner of Lake Wazeecha. This company was allowed to have two "pop up" rental events last summer. These went quite well, and I would recommend approving this agreement for the summer. I propose a similar arrangement as our winter concessionaire agreement, where Wood County retains a % of sales. I have included a draft agreement for your review.

Construction Supervisor Report, by Dennis Quinnell

Current Projects

- White Beach Remodel is nearing completion.
- Sobczak Concrete will be laying the concrete slab for the North Park firewood storage building project. We will start as soon as the weather permits.
- River Cities Construction provided the low quote, and will be performing roof repairs on the South Park Ranger Cabin and the South Park Red Beach Vault Toilet projects. These were damaged in the windstorm last July.
- River Cities Construction also provided the low quote for remodeling the Willow Run Vault Toilet at South Park. This project will occur this summer.

Maintenance Operations

- Crews are are getting buildings and grounds prepped for opening . Campground and park areas open May 1st..
- All boat launches are open.

Notice of Park Openings and COVID-19 Restrictions

We recognize that our parks, forests, trails and open spaces can continue to be used in a safe manner during the COVID-19 pandemic. We ask that our visitors continue to follow the guidelines outlined by Governor Evers' most recent "Safer at Home" order, which runs through May 26, 2020.

Among other things, the "Safer at Home" order requires the following: persons reduce non-essential travel, practice 6' social distancing, and avoid social gatherings in groups of 10 or more people. Please stay home if you are sick.. In following these requirements, with the goal of keeping our guests and employees safe, we will be opening various park and forestry areas on May 1st, with a few restrictions.

Non-Compliance to the Safer at Home order may lead to closed parks, please do your part to follow local, state, and Federal CDC guidelines.

Campgrounds:

- Dexter, North, and South Wood County Park campgrounds will open Friday, May 1st 2020.
- We have stopped taking reservations for the month of May. All existing reservations are valid, and campers may come and self-register for sites at the campground. Currently, people may make new reservations for June-October, 2020.
- Group sites at North and Dexter Park will be closed through May 26th. Our office staff will contact individuals with existing reservations during this time.
- SHOWER BUILDINGS WILL REMAIN CLOSED. Only vault toilets will be available. Camper water filling and dump stations will be open and available for use. Shower building closures will be reviewed on a week to week basis. In addition, drinking fountains and hand pumps will not be available during this time. Please plan accordingly.
- Registered campers should limit site occupants and visitors to immediate family members from common households.
- Wood and ice sales will be available for purchase by cash or check. Reminder that there is NO OUTSIDE FIREWOOD allowed in any park areas.
- If you wish to cancel or change an existing reservation in May, you may do so by calling our office. Full refunds, gift certificates, or date changes are allowed if you contact our office **prior to** scheduled date of arrival. No refunds will be granted if request is made on expected date of arrival, or thereafter.

OUTDOOR RECREATION EQUIPMENT RENTAL VENDOR AGREEMENT

AGREEMENT executed as of this ______ day of ______, 2020, by and between WOOD COUNTY, (hereinafter referred to as "WOOD COUNTY"), and NORTHWARD, LLC, a Wisconsin Limited Liability Company, (hereinafter referred to as "NORTHWARD":

WHEREAS, NORTHWARD owns and operates a business which rents outdoor recreation equipment including, but not limited to, kayaks and related equipment; and

WHEREAS, WOOD COUNTY wishes to make available to its members and guests non-motorized water recreation equipment on a rental basis; and

WHEREAS, NORTHWOOD has a supply of suitable rental equipment and necessary staff to provide rentals for members and guests of WOOD COUNTY;

NOW, THEREFORE, in consideration of the mutual agreements set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. WOOD COUNTY agrees to make available to NORTHWARD, a suitable location on real estate owned by WOOD COUNTY for the operation of NORTHWARD'S rental business and for storage of NORTHWARD'S kayaks and other equipment.
- NORTHWARD shall pay Wood County <u>15%</u> Net Sales generated from all sales and rentals on WOOD COUNTY property, and shall bear all costs of operating the rental business including, but not limited to staff compensation, insurance, and maintenance and equipment replacement. On a monthly basis, NORTHWARD shall provide payment, along with a detailed summary of total sales and rental totals from use of Wood County properties.
- 3. NORTHWARD hereby agrees to indemnify, defend, protect, and save WOOD COUNTY, it's officers, directors and members, harmless from and against any claimed damage, loss, liability, injury, cost and expense (including reasonable attorney's fees and expenses) in connection with any personal injury or any loss or damage to any property or facilities arising out of or resulting in any way from the acts of omissions to act, negligence, or willful misconduct of NORTHWARD, its directors, officers, employees, or agents, in connection with the exercise of its rights and performance of its obligation under the terms of this Agreement.
- 4. NORTHWARD hereby agrees to indemnify, defend, protect, and save WOOD COUNTY, its officers, directors and members, harmless from and against any claimed damage, loss, liability, injury, cost, and expense (including reasonable attorney's fees and expenses) in connection with any loss or damage to any equipment stored by NORTHWARD on WOOD COUNTY property.
- 5. This AGREEMENT shall be interpreted and construed in accordance with the laws of the State of Wisconsin without regard to its conflict of laws and principals with all disputes to be venued in Wood County, Wisconsin.

- 6. The parties agree that this AGREEMENT creates no partnership between or joint venture of WOOD COUNTY and NORTHWARD.
- 7. This AGREEMENT shall become effective upon the authorized execution by or on behalf of both parties and shall continue in force and effect until ______.
- 8. This AGREEMENT may be canceled with a 30-day written notice from either party. In addition, either party may cancel events previously agreed upon or scheduled with a 24-hour notice.
- 9. This AGREEMENT shall follow Schedule A as set annually by mutual agreement.

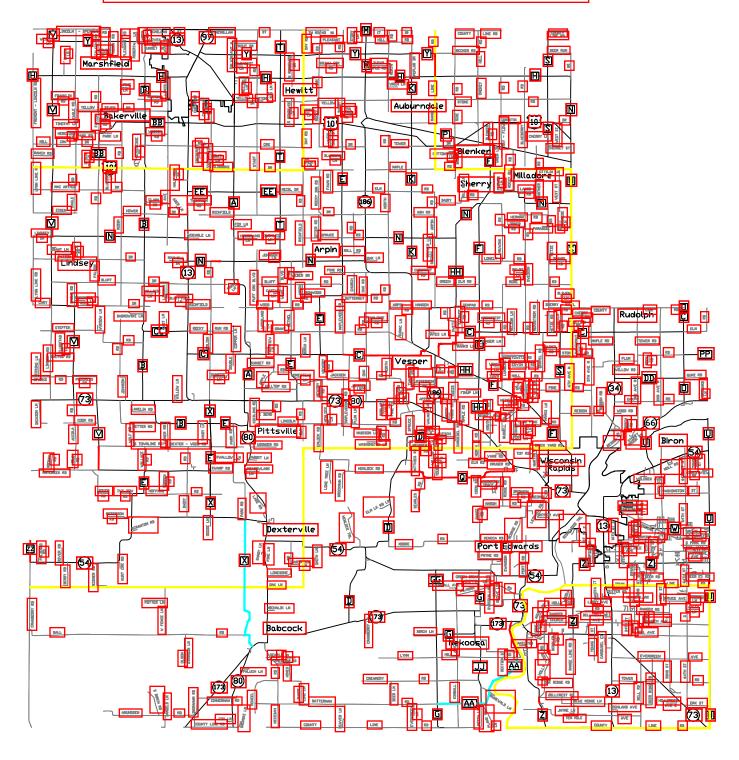

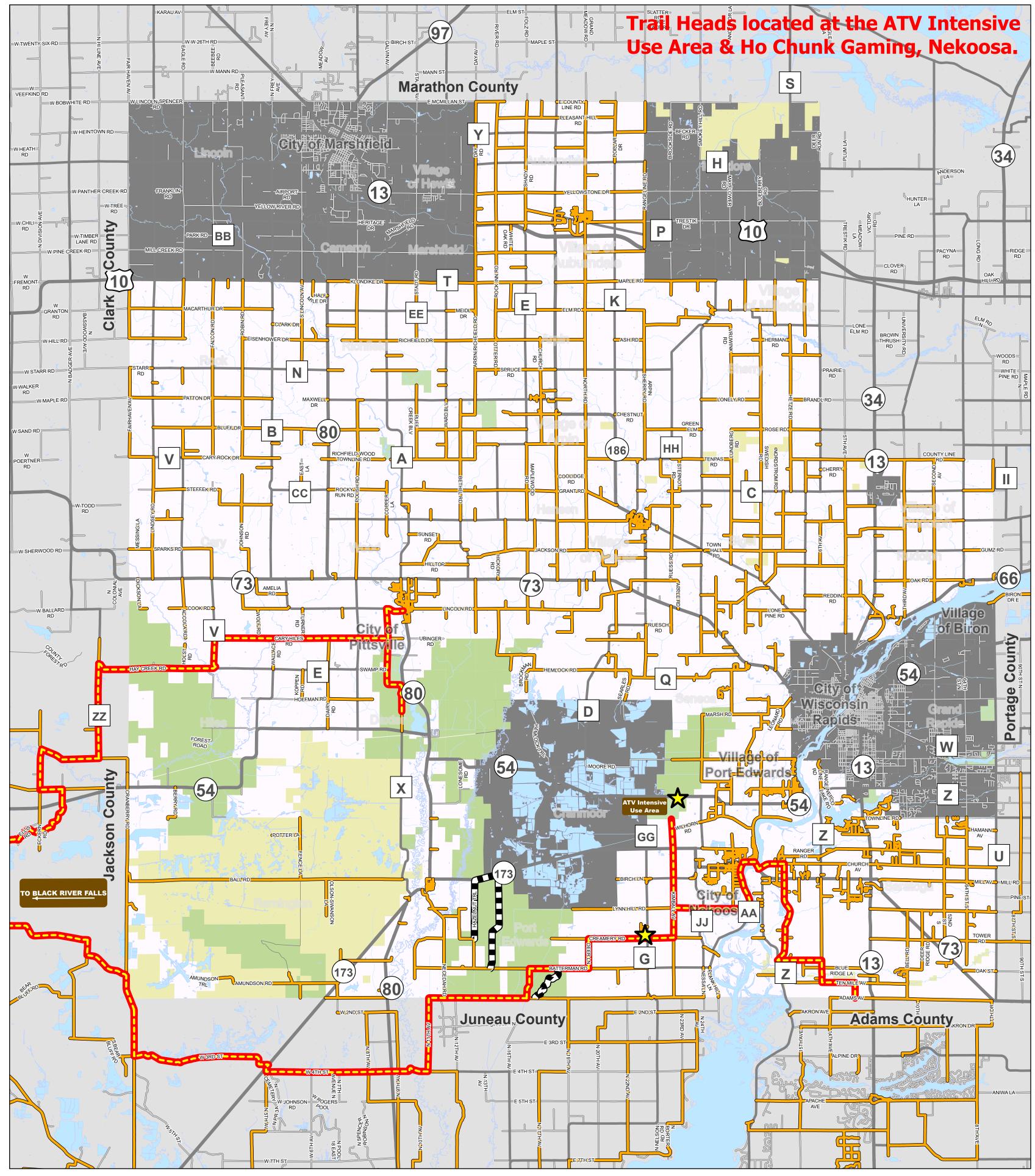

Flagging Certification Policy

Flagging is a dangerous activity and the project engineer must make sure the operation is being performed correctly. Field staff should familiarize themselves with the Wisconsin Flagging Handbook available online at:

https://wisconsindot.gov/Pages/doing-bus/local-gov/traffic-ops/manuals-and-standards/manuals.aspx

Before the flagging operation begins, ask to see the flaggers' certification. The contractor may present all the certifications at the preconstruction meeting or the flaggers may show a certification card with their name, instructor name, date of certification, and expiration date. All flaggers must be properly trained and are required to be certified. Do not allow flagging operations to begin until certified flaggers are available. The flagging techniques, proper equipment, and PPE can be found in the Wisconsin Flagging Handbook.

All flagging operations must have the proper advance warning. This can be found on SDD 15c12. Ideally this will be set up and taken down as the flaggers move, however, the signs may be taken down or set up within 1/2 hour of the work starting or stopping.

Make sure the flaggers have positioned themselves correctly to give themselves an escape route from an errant vehicle and so they can be seen by drivers. Flaggers are not allowed to sit/lean on chairs or in/on vehicles while the operation is being conducted. Make sure the flaggers are paying attention to traffic and not distracted.

Temporary Portable Rumble Strips (TPRS) are required for all flagging operations. The TPRS have a spacing requirement based on the posted speed limit. Make sure the TPRS have been installed according to the manufacturers' recommendations. This also includes the strips being installed with the correct side up, and on the proper surface. Monitor the TPRS for movement and have the contractor adjust when necessary. TPRS are not required for roads with speeds limits of 35 mph or less. Do not use TPRS on loose gravel or milled surfaces because of excessive movement of the strips.

For flagging operations with two or more flaggers, radios must be used for communication.

When the flagging operation exceeds 2 miles, a pilot car must be used. This is to better guide traffic through the work zone and control speeds. As with any longer flagging operation, the length of queues must be considered. Direct the contractor to adjust the flagging operation if queuing exceeds the advance warning.

Additional flaggers are needed at intersections. A single flagger may be sufficient at an intersection, however at higher volume side roads, an additional flagger may be needed if they cannot control all the approaches. The flaggers may use flags at intersections.

If the project will be intersecting a railroad, make sure to contact the railroad company for any further requirements. An additional flagger may be needed at the railroad tracks to stop traffic for trains and to prevent drivers from stopping on the tracks.

Flagging at night will require the flaggers to be illuminated properly as to not blind drivers.

TIMBER SALE CONTRACT EXTENSION POLICY

The Wood County Highway Infrastructure and Recreation Committee is responsible for the extension of timber sale contracts and would like to see sales cut in a timely manner. The Committee grants contract extensions and associated stumpage increases at their discretion. Each contract extension/stumpage increase will be determined on a case by case basis with factors such as: access, weather, ground conditions, silvicultural objectives, balances owed, natural disasters, etc. taken into account.

In general, the Committee may be more willing to grant first extensions without any stumpage increase if a job has been started. Contracts that are two years old with no activity, and contracts that have had more than one extension are of special concern and are more likely to have stumpage increases assessed. There may be special contracts that have no flexibility in length due to timing of silvicultural considerations, storm damage, etc. In these cases contract length will be fixed, and the contractor should expect to be penalized for not completing the sale in the time specified in the contract. Additionally, contracts that have had multiple extensions may not be extended in the future.

The typical contract extension will be for one year. The extension/stumpage increase schedule is as follows:

Extension #1	0% to 10% (maximum) increase
Extension #2	0% to 10% (maximum) increase
Extension #3	10% (minimum) to 25% (maximum) increase

Additional extensions will only be granted in cases of extraordinary circumstances. Stumpage increases associated with these extensions will be determined by the Committee on a case-by-case basis.

Contract Extension Notes – May 2020

#719 Schreiner Forestry

- Bid September 2013 original contract expiration: October 1, 2016.
- Contract extensions: four (current extension expired March 31, 2020)
- % completion = 35%
- Job constraints: Seasonally wet access, ground needs to be frozen for access across marsh. Oak wilt restriction. *This is one of the poorest access sales we have had on the Wood County Forest during my time with the county.*
- Considerations: Contractor has completed many contracts with Wood County in the past, has had a good payment history, and quality of work is above average. Currently this is the only contract this contractor holds on Wood County Forest. Was not able to operate on this contract this past winter due to extreme wet ground conditions. Access to cutting units crosses a couple marshes that were flooded all winter and did not freeze sufficiently to support logging machinery and pulp trucks. Generated **\$0.00** total revenue to the Wood County Forest in the past year.

Recommendation:

Grant contract extension to March 31, 2021 with no increase in stumpage.

#724 Futurewood

- Bid May 2014 original contract expiration: June 1, 2016.
- Contract extensions: four (current extension expired March 31, 2020).
- % completion = 92%, 3 to 4 acres remain to be cut.
- Job constraints: Seasonally wet access, ground needs to be frozen for access and to operate in portions of sale area.
- Considerations: Contractor has completed many contracts in the last few years, has had an excellent payment history, and quality of work is excellent. Currently holds 7 other contracts on Wood County Forest. Cut/operated **4 contracts** (completed 3) according to specs in the past year and generated **\$52,549.66** total revenue on all contracts to the Wood County Parks and Forest. *Note: One sale was a storm damage salvage harvest on park property on the north side of Lake Wazeecha. Contractor arrived quickly after short notice.*

Recommendation:

Grant contract extension to March 31, 2021 with **no increase in stumpage - or - release contractor from obligation to complete the harvest without penalty.**

#741 Thurs Logging

- Bid April 2016 original contract expiration: April 1, 2018.
- Contract Extensions: Two (current extension expired March 31, 2020). Last extension carried a 5% increase in stumpage.
- % completion = 17%
- Job constraints: Seasonally wet access, portions of sale area require frozen conditions for access. Oak wilt restriction.
- Considerations: This is the only contract this contractor holds on Wood County Forest. Contractor quality of work on past contracts has been very good. Contractor did not attempt to operate on this contract over the past winter.
- Contractor cut one small patch (about 4 acres) just before deer season (fall 2019).
- Total sale area encompasses 23 acres, in 5 small cutting units.
- Contractor has generated **\$0.00** total revenue to the county forest in the past year.

Recommendation:

Grant contract extension to March 31, 2021. Consider 5% increase in stumpage.

#744 Delaney Forest Products

- Bid April 2016 original contract expiration: April 1, 2018.
- Contract extensions: Two (current extension expired March 31, 2020).
- Contract extensions have been without any increase in stumpage.
- % completion = 0%
- Job Constraints: Seasonally wet access, Requires frozen ground for access and to operate, oak wilt restriction, access across private land.
- Considerations: Contractor has completed many contracts in the last few years. Contractor currently holds no other contracts on Wood County Forest. Contractor has good history of payments and quality of work is excellent. Contractor did not attempt to operate on this contract over the past winter.

Recommendation: Grant contract extension to March 31, 2021. **Consider 5% increase in stumpage.**
