# PROCEEDINGS OF WOOD COUNTY BOARD OF SUPERVISORS March 21, 2017 - 9:30 a.m.

The Wood County Board of Supervisors composed of nineteen members convened at the Wood County Boardroom in Wisconsin Rapids, Wisconsin on March 21, 2017.

Chairman Pliml called the meeting to order at 9:30 a.m.

Supervisor Fischer gave the invocation and led the Pledge of Allegiance.

Motion by Feirer/Hamilton to approve the minutes of the previous meeting. Motion carried by voice vote.

Motion by Zurfluh/Hamilton to accept the resignation of Bill Clendenning from the Health & Human Services committee. Motion carried by voice vote.

Motion by Hamilton/Zurfluh to appoint Brad Kremer as District #8 Supervisor. Motion carried by voice vote. Supervisor Kremer will be sworn in on Thursday, March 23<sup>rd</sup> by the Deputy Clerk Miner

Motion by Rozar/Fischer to approve the following appointments:

#### **RESOLUTION 17-3-1**

Introduced by: Executive Committee and Health & Human Services Committee

INTENT & SYNOPSIS: To amend the 2016 Veterans Services budget for changes in revenue and expenditures not anticipated during the original budget process.

## SPECIAL ORDER OF BUSINESS DESIGNATE WILD PARSNIP AS A NOXIOUS WEED

Shane Wucherpfennig, County Conservationist encouraged the Wood County Board to designate Wild Parsnip (Pastinaca sativa) as a "noxious weed" within the county boundaries. The presentation illustrated why county officials should be concerned and what actions they could take as a governing body to help prevent the spread of this invasive monster. Treatment options were discussed along with how to identify the species. The presentation highlighted the Wisconsin Code Chapter 66.0407 Noxious Weeds and what authority a governing body has by ordinance or resolution to declare the weed as noxious within its respective boundaries. Much discussion followed the presentation.

#### **RESOLUTION 17-3-5**

Introduced by: Conservation Education & Economic Development Committee

INTENT & SYNOPSIS: To encourage the Board of Supervisors for the County of Wood to designate wild parsnip (Pastinaca sativa) as a "noxious weed" within the county boundaries.

FISCAL NOTE: none.

Motion by Fischer/Zurfluh to adopt Resolution 17-3-5. Motion carried unanimously. Excused were LaFontaine, Kremer and Machon.

Committee minutes presented: Judicial and Legislative, Joint Legislative Committee, Criminal Justice Task Force, Highway, Infrastructure & Recreation-Supervisor Clendenning encouraged the supervisors to attend an informational meeting regarding the Powers Bluff Development Project on Wednesday, March 22, beginning at 7:00pm, at the Powers Bluff County Park shelter building, Aging and Disability Resource Center of Wisconsin, McMillian Library, SCLS Board of Trustees.

## SPECIAL ORDER OF BUSINESS RIVER BLOCK TRANSITION UPDATE

Building Maintenance Director, Reuben Van Tassel gave a progress update. Third floor is looking great. A lot

of work left to do on first and second floors but as of now it looks like they will meet the deadline of April 1<sup>st</sup> for substantial completion leaving two to three weeks for punch list items to get everything cleaned up and ready for move in. The Health department is on track to move in the week of April 24<sup>th</sup> and more departments to follow shortly after that starting on May 1<sup>st</sup>. Reuben then answered questions pertaining to the budget for the project and stated that they are still within budget.
