- 1. At 9:00 a.m., the meeting was called to order.
- 2. Public comments. None at this time.
- 3. The minutes for the January 6, 2022, meeting were reviewed and declared approved as presented without objection.

- 5. There were no new animal claims against the County.

Opioid Settlement. Nothing new insofar as the first settlement but my expectation is that there will be significant settlement dollars available for programming for 2023 and a few departments, like Human Services and the Sheriff's Department (Jail), will need to give some thoughts on recommendations for best uses.

Meadow Brook 4-H Club. As you may recall, the County brought an action against the defunct Meadow Brook 4-H Club so as to take title to the real property owned by that club such that it can either be used by another 4-H group or sold and the proceeds used by the County's 4-H program. I have filed a motion for default judgment in the action, which motion will be heard by the court on March 2. The basis of the lawsuit here is a rarely used legal mechanism, which doesn't fit as neatly as I would like into the facts we have and, if litigation doesn't work, we will have to be creative in figuring out a methodology for addressing the situation. I will keep the committee posted.

New Committees. In just a few months there will be one or more new members on the county board and there will be the reassignment of the committees. It is an awkward time, in a way, for department heads as we want to share lots of information with our new oversight committee members but recognize others want to do the same and it isn't profitable for anyone to overload the new members with levels of information they won't be able to absorb. Also, normal committee meetings don't lend themselves well to such an educational process. You folks have all been through this process, so you should give some thought on how best to bring a new supervisor and new committee members up to speed. If there is anything I or other department heads can do to facilitate this process, please let us know.

So that is one side of my mind talking, the bureaucratic side that wants to indoctrinate new committee members and supervisors as soon as possible lest they upset the apple cart by questioning how things work around here. Face it, you supervise people who get comfortable in doing things a certain way but there is both good and bad to stasis. In overseeing management, you not only need to understand what we are doing with the resources you have allocated but why we are doing it the way we are and why it can't be done for less. It is hard to come up with new ideas if no one challenges the old ones. It is part of your job to do that or make sure we are.

RE: Business Torts

Recently I advised a County employee who was dissatisfied with how a vendor was performing under a contract that the County had limited recourse for remedial measures. One way to address the problem was to advise the contractor if they didn't improve their performance, their reputation would be tarnished within the limited community in which they do business. Upon writing this, it dawned on me that I needed to temper what the County employee might say to others so that the County isn't sued for a business tort. It was further apparent that this information would be useful to others in the future and should be included in the memos that County staff have access to. Even though I may access these memos more than others in counseling my client, these memos provide an efficient way to address recurring legal issues. In any event, we will proceed here in reviewing some of the business torts that involve saying bad things about a contractor.

A tort is a wrongful action. A business tort is a wrongful action directed at a business. There are a number of so-called business torts, including:

- Wrongful interference with contractual or business relationships.
- Appropriation of another's name or identity without permission.
- Disparagement of business property or reputation.
- Infringements of rights in trademark, patents, and copyrights.
- Misappropriation of trade secrets.

It is the first and third of these business torts to which we will direct our attention here.

There are two categories of the business tort involving wrongful interference, that being the wrongful interference with a contractual relationship and the wrongful interference with a business relationship. This memo is concerned with the second type of these business torts but it is worthwhile to understand the differences between the two.

There are three elements to a wrongful interference with a contractual relationship; they are:

- 1. A valid contract must exist between two parties.
- 2. A third party must know this contract exists.
- 3. The third party intentionally causes one of the parties to a contract to break the contract.

The type of contract that a Wood County employee is likely to breach in this context is one between an employer and employee. So, if a County employee knows that a person is under a contract with an employer and we induce the employee to breach that employment contract, then the County is guilty of the wrongful interference with a contractual relationship. So how does this apply in the real world? Well, if Wood County has an opening for a social work supervisor and we recruit an employee of a neighboring county to apply for the job, the person we are recruiting is likely an at-will employee of the neighboring county and, therefore, there is no concern here. However, say Wood County is looking to recruit a psychiatrist and we are aware a person qualified for the position is under a contract with the neighboring county, albeit, we don't know the terms of the contract but are aware the person is not just a county employee of the neighboring county but is actually working under a contract, then we would be violating the law if we induce the psychiatrist to break their contract with the neighboring county. We could certainly communicate with the psychiatrist to ascertain what the terms of their contract are and if they want to consider employment with Wood County upon the expiration of their current contract. In this scenario it would be important to obtain a copy of the contract the psychiatrist is under to make sure we are not acting to get the subject to violate it.

The wrongful interference of a business relationship is the second and more complex of the interference with business torts. The concept behind this tort is that competition is good but predatory behavior is bad. What is the difference? General efforts to attract customers, like advertising, is acceptable. Solicitations directed specifically at the customers of a company may cross the line. So, how does this tort apply within the context of not getting in trouble by threatening a vendor with damaging their reputation if they don't perform under a contract the way we expect them to? If a vendor is doing poor work for Wood County, they are probably doing poor work for others as well and the vendor may be facing the demise of their business. If the vendor has one or two main competitors and the competitors are working hard to drive the vendor out of business and these competitors use our experiences with the vendor to do so, the vendor may seek legal counsel and draw us into litigation for collaborating in the vendor's inability to establish or maintain business relationships with others. A solid defense to this type of complaint would be that everything said by Wood County staff was accurate. If we stick with the facts and don't embellish them, we will stay out of trouble or at least be able to extricate ourselves from it.

There are always those who think it wise to simply say nothing to others about the quality of work of a business or an individual; they will give no reference good or bad. Although there is short-term logic in doing so, it is a poor plan from a long-term perspective. Reputations for businesses and individuals are important for a reason and if Wood County adopts a practice of not sharing accurate concerns about reputations of others, then no one will share their perspectives with us and we will end up hiring contractors and employees that no one else would out of designed ignorance.

The final area of business torts we need to deal with is the disparagement of business property or reputation. The focus here is on the disparagement of a business's reputation, sometimes called business defamation. If a County employee complains to their counterparts in other counties about the quality of work being provided by a vendor or the vendor's compliance with their

contract with us, do we run the risk of running afoul of illegally disparaging the reputation of the business? The elements of a disparagement of a business reputation cause of action are as follows:

- 1. A false statement about the business.
- 2. The statement is communicated to a third party.
- 3. The statement was made with at least a negligible level of intent; in other words, the person who made the statement did not act with the level of reasonable care that an ordinary person would exercise.
- 4. The statement caused damage to the business.

It is the first and third elements that are typically the issue as the statement is always going to have been shared with a third party and the business is always going to be able to allege some negative consequence resulting from the statement. So, the first element seems straight forward enough – is the statement true? Yet, this isn't the case. Statements like: they don't stand behind their contract, they do a lousy job, they never respond on time, they take the cheap approach - these are the kinds of statements that are made and the person making them makes them because they are unhappy with the contractor/vendor but the statements may not actually be true and someone later on (the judge or jury) is not going to be looking from their frustrated vantage point. Instead, they will be applying the elements: Was the statement true and, if not, was the person who said it negligent in saying it? Possibly. Which isn't an acceptable situation.

So, what advice can be given to make sure we aren't exposing the County to liability for discussing a contractor's performance with others? These types of statements work:

- We have been unhappy with the contractor's performance.
- We would be leery about contracting with them again.
- We don't recommend them.
- We should have modified their contract before we signed it.
- We didn't get what we thought we would.
- I don't like working with them.

These are all strong statements that are true; they can't be proven untrue. These are statements of perceptions and feelings. None of the statements gets into the facts of why they are displeased, so they are safe. If pressed as to why, the employee really needs to avoid the specifics and just state that we weren't happy. That is all we should expect in obtaining references and comments from others and it should be all we are willing to say.

RESOLUTION 2022 - 15

Re: Request State to Revise the Current Real Estate Transfer Fees Revenue Sharing Formula

WHEREAS, the collection by counties of a real estate transfer fee was mandated by the State of Wisconsin in 1969, and included a requirement that counties remit 50% of all transfer fees collected to the State; and

WHEREAS, in 1981 the State arbitrarily changed the transfer fee formula to now require counties to remit to the State 80% of all transfer fees collected; and

WHEREAS, the County through the Register of Deeds office assumes the annual operating costs of recording all real estate transfers occurring in Vilas County, including the collection of real estate transfer fees; and

WHEREAS, in 2021 Vilas County collected \$1,576,841 in real estate transfer fees with the County's 20% retained share totaling \$315,368, and was required to remit 80% or \$1,261,473 to the State; and

WHEREAS, Vilas County real estate transfer fee collections as averaged over the past five years totaled \$5,208,810 of which the County retained \$1,041,762; and over that same period \$4,167,048 was remitted to the State; and

WHEREAS, in 2021 the State of Wisconsin has built up a budget surplus of approximately \$2.5 billion dollars, while many Wisconsin counties continue to struggle financially due to the ever-increasing costs of providing county government services in an inflationary economy, coupled with the financial restrictions imposed by State mandated levy limits; and

WHEREAS, in an effort to financially assist all Wisconsin Counties, Vilas County requests that the State of Wisconsin return the real estate transfer fee share formula to again allow Wisconsin Counties to retain 50% of all total real estate transfer fees collected, with 50% to be remitted to the State.

NOW, THEREFORE, BE IT RESOLVED by the Vilas County Board of Supervisors in session this 22nd day of February, 2022 that we hereby request that the State of Wisconsin revise the real estate transfer fee share formula to again allow Wisconsin Counties to retain 50% of all real estate transfer fees collected, with 50% to be remitted to the State.

BE IT FURTHER RESOLVED, that a copy of this resolution is sent to Governor Tony Evers, all members of the State Legislature representing Vilas County, the Wisconsin Counties Association and all other Wisconsin Counties.
