1. At 1 p.m., Chairman Clendenning called the meeting to order.

- 2. Public comments. None.
- 3. Moved by Wagner, seconded by LaFontaine, to approve the minutes of the May 5, 2017, Committee meeting. All ayes.

 Discussion had on the difference between the housing of individuals treating for AODA issues, which stopped with the closure of the 10th & Airport facility, and the treatment of these individuals, which continues and never stopped. The Health & Human Services Board has determined it will not be reopening the 10th & Airport CBRF. Judge Wolf may or may not continue to pursue the issue.
- 4. The Committee reviewed department reports and monthly voucher reports:

Moved by Curry, seconded by LaFontaine, to approve the reports and payment of vouchers of Branch I, II, and III, Child Support, Clerk of Courts, Register of Deeds, Family Court Commissioner, Corporation Counsel, District Attorney, and Victim/Witness. All ayes.

- 5. The Wood County Child Support Agency received an excellence in child support enforcement award for 2016.
- 6. There was one new notice of injury/claim filed with the County. The notice of injury and claim of Mary Jo Smits was reviewed by the Committee and will be forwarded to the county board.
- 7. There were no new animal claims against the County.
- 8. The Committee reviewed correspondence and legislative issues. Amy Sue Vruwink appeared on behalf of U.S. Representative Ron Kind's office.
 - a. Southeast Wood County Groundwater group report. The group has met 5 times now. Discussion of possible future projects were considered. The group is tracking what Portage County is doing. The group is a subcommittee of the CEED Committee and will be forwarding its minutes on to that committee.
 - b. Corporation Counsel memo entitled "Open Meeting Law: Specificity Required for Agenda Items" was reviewed by the Committee and will be submitted to the county board.

c. Update from CEED Committee on wild parsnip. Land Conservationist Shane Wucherpfennig gave an update as to how his department has been pursuing the wild parsnip problem. Local farmer John Eron shared what is happening in Portage County related to wild parsnip and what the Farm Bureau is doing. Mr. Eron explained the importance of education and programming verses state imposed regulations. In Wood County the primary efforts right now are on mapping this and other invasive plants. It is expected that Wood County will join with other counties to seek funding for eradication grants.

9. County Board rules.

- a. Resolution to consolidate Human Services and Edgewater Haven into one department was reviewed and discussed. Supervisor Rozar explained how there are efficiencies that can be obtained by consolidating Edgewater Haven in with Norwood Health Center under the Human Services Department. Moved by Leichtnam, seconded by Wagner, to support the resolution consolidating Human Services and Edgewater Haven into one department. All ayes.
- b. Membership on Executive Committee and method of selecting committee chairs. Supervisor Clendenning explained his desire to have a 5-member Executive Committee elected directly by the county board with the Executive Committee then determining the membership of the other committees. Those other committees would determine via election their own chair. Clendenning will bring back one or more resolutions at the next meeting in support of his proposals. There were some questions and comments pertaining to Supervisor Clendenning's proposals.

MONTHLY REPORT TO THE JUDICIAL AND LEGISLATIVE COMMITTEE July 2017

- 1. <u>Goals</u>. Not much happened in this area this month. See comment #6.
- 2. <u>Mark Eswein Complaint Resolution Process.</u> Mr. Eswein, the former Highway Dept. employee who appealed his termination via the Complaint Resolution Process had his final review by the county board at the June county board meeting. Paula Tracy and I assisted County Board Chair Pliml in arranging for that hearing. I think it is unlikely that Mr. Eswein will pursue any type of discrimination action against the County. The committee may want to provide input on the hearing procedures.
- 3. I gave a few presentations over the past month pertaining to civil commitments. One presentation was to a large group of social workers and nurses and the other was to a smaller group of about 30 law enforcement officers. Unlike most of my presentations, these will be compensated via grants and should result in excess of \$1,500 in revenues.
- 4. I am still working with the UW Commission on their cell tower project, principally on the contract and the wetlands issue.
- 5. 2017 Municipal Attorneys Institute. As I have explained to some of you before, the corporation counsels' association puts on spring and fall training sessions but they are not particularly worthwhile from my perspective, so I seldom attend them. Meanwhile, the city and village attorneys put on a very useful annual training session that I typically attend as do many of the other corporation counsels. I don't care much for attending seminars, especially multi-day affairs, as they don't seem to me to be efficient or cost effective ways to learn. Anyway, I attended this year's conference and have a binder containing all of the presentation materials from the programs that I will use in the future for reference materials. As usual, the presentations were quite diverse, including: the regulation of cell towers, police power and home rule, ethics for municipal attorneys, the fourth amendment, municipal finance issues, risk management and insurance issues in contracting, software licensing, an update on governmental takings, conducting internal investigations, immigration issues and finally, legislative and municipal case law updates.
- 6. Both Lisa and I use a lot of our vacation time over the summer months. Since we don't employ replacement staff for either of us, rather, I cover what needs to be done immediately with respect to her workload and she brings in outside counsel to show up for court for me, we tend to get a bit behind in non-pressing matters over these months. It is not a problem per se, it is just a situation that you should be aware of

MONTHLY REPORT TO THE JUDICIAL AND LEGISLATIVE COMMITTEE

Prepared by Child Support Director Brent Vruwink

- Staff attended training on the TimeStar, electronic time card system. The Child Support Agency will be having staff manually enter their time on the system.
- I plan to attend the Department Head meeting on July 13th.
- I will be attending WCSEA meetings in Black River Falls on July 13th and 14th.
- As I have mentioned in recent reports the Child Support Agency has seen an increased workload with the advent of e-filing. We estimate that it takes about 8 hours per week to complete the e-filing work. We have a shared employee with Maintenance and Finance that currently works 4 hours per week for the agency. Maintenance has indicated they would like to discontinue sharing the employee with Child Support in 2018. In order to make up for the loss of the shared employee and the increasing workload from e-filing, I will be discussing with you the possibility of hiring a person to work 12 hours per week to do e-filing and scanning work.
- The state has asked Wood County to participate in a review of the Self-Assessment manuals the Bureau of Child Support reviewers use during the annual Self-Assessment. I appointed Vicki Stoflet from our agency to be part of the review team.
- As an agency we are working on a process to clear up as many outstanding child support warrants as possible. Our goal is not to arrest and incarcerate the individuals with warrants but to help them overcome the barriers that are preventing them from making payments or finding employment.
- Two staff members and I will be attending the Transition Fair at Jackson Correctional Institution on August 1st. This is an opportunity for us to connect with inmates that will be released from prison in the near future.
- Shannon Lobner and I continue to be involved with the statewide data warehouse project.
- The May performance numbers are in and remain strong. We currently are meeting and exceeding all the federal performance measures.
- The current IV-D case count is 3,957.

INTENT & SYNOPSIS:	To oppose legislation to repeal Wisconsin's	
prevailing wage law.		

FISCAL NOTE: none

WHEREAS, Wisconsin's prevailing wage law was enacted in 1931 and required employers to pay workers what local workers were being paid in the area. Changes were made to the law in 1996 and significant changes were made in the 2015-17 State Budget. Beginning January 1, 2017, prevailing wage was eliminated for all but state projects, state agencies, and state highway projects if they are \$48,000 or more for single trade and \$100,000 or more for multi-trade. Federal prevailing wage laws are still effective on any public building or works project that receives \$2,000 or more of federal funds; and

WHEREAS, Governor Walker's 2017-19 Biennial Executive Budget includes language repealing Wisconsin's prevailing wage requirement. Both the Senate and Assembly have also proposed legislation eliminating Wisconsin's prevailing wage law; and

WHEREAS, this resolution urges the Legislature to support Wisconsin workers by opposing the repeal of Wisconsin's prevailing wage law because the skilled construction tradesmen and women working on our public infrastructure deserve to be paid a fair minimum wage. Wisconsin is already experiencing a worker shortage and a skills gap. Repealing prevailing wage will only make the problem worse.

NOW, THEREFORE, THE WOOD COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES to urge the Governor and State Legislature to protect Wisconsin workers by opposing legislation to repeal Wisconsin's prevailing wage law.

BE IT FURTHER RESOLVED that the Wood County Clerk be directed to forward a copy of this resolution to all Wisconsin counties, and to the Governor and Legislature.
