Lori Heideman stated she is working on getting addresses correct. She discussed Kari's Law, which ensures anyone can reach a 911 call center when dialing 911 from an MLTS. It also sends a notification to a central location on or off site, such as a front desk or security kiosk.

Lori also discussed text and video 911 calls.
