Dan Brandl from IT talked about the update that is happening on April 25, 2018. He stated they are moving data to new servers. CIS is scheduled to be down for eight hours starting at 9:00 a.m. Dan stated since he started with the Wood County they have been moving servers over little by little.

Shawn Woods is having issues with information not exporting in from the Tracs Transfer.

Lorrie Krokstrom from Marshfield stated they are having issues posting.

Lorrie Krokstrom stated she would like to see a subcommittee for IBR.
