#### COMPLAINT

NOW COMES THE PLAINTIFF, Jeffrey Lilley, by his undersigned counsel, Paul Kinne OF GINGRAS, THOMSEN & WACHS, LLP, and submits the following as his complaint in this matter.

#### NATURE OF PROCEEDINGS

1. This is a civil rights action to redress the deprivation under color of law of Plaintiff's rights, as secured by the Fourth and Fourteenth Amendment of the United States Constitution and 42 U.S.C. § 1983, which occurred when defendants unlawfully seized Plaintiff with excessive force.

#### JURDISDICTION AND VENUE

5. This court has jurisdiction over plaintiff's claims pursuant to 28 U.S.C. §

1331 (federal question) and 28 U.S.C. § 1343 (civil rights).

Venue in the Western District of Wisconsin pursuant to 28 U.S.C. §
 1391 is proper insofar as the defendant is located in this district, and the events giving rise to the claim took place within this district.

#### PARTIES

2. Jeffrey Lilley ("Mr. Lilley") is an adult resident of the State of Wisconsin.

3. Defendant Wood County, with offices of its executive at 400 Market Street, Wisconsin Rapids, WI 54494, is and was at all times material hereto, a Municipal Corporation organized under the laws of the State of Wisconsin. Pursuant to Wis. Stat. § 895.46, Wood County is obligated to indemnify all Defendants in this action.

4. Defendant Deputy John Matthews ("Mr. Matthews") is an adult resident of the State of Wisconsin. At all times relevant to this action, Defendant Deputy Matthews was employed as a deputy officer by the Defendant Wood County Sheriff's department.

5. Defendant Deputy Derek Phillippi ("Mr. Phillippi") is an adult resident of the State of Wisconsin. At all times relevant to this action, Defendant Deputy Phillippi was employed as a deputy officer by the Defendant Wood County Sheriff's department.

4. Defendant Lieutenant Kalvin Dorshorst ("Mr. Dorshorst") is an adult resident of the State of Wisconsin. At all times relevant to this action, Defendant Lieutenant Dorshorst was employed as a lieutenant officer by the Defendant Wood County Sheriff's department.

## FACTUAL ALLEGATIONS 2

 On August 11, 2020 Defendants Matthew, Dorshorst, Phillippi (together, "the defendant officers") were dispatched to 2610 32<sup>nd</sup> Street North in the Village of Biron, Wood County, Wisconsin.

9. When the defendant officers arrived, they found Plaintiff Lilley lying in bed.

10. The defendant officers demanded that Plaintiff Lilley get up and leave his bed.

11. At the time, Plaintiff Lilley was naked.

, '

12. Plaintiff Lilley suffers from Chronic Obstructive Pulmonary Disease (COPD).

13. Plaintiff Lilley followed the defendant officers' orders, and began to get up.

14. As he did, the defendant officers attacked Plaintiff Lilley.

15. The defendant officers grabbed Plaintiff Lilley and threw him to the floor.

16. While Plaintiff Lilley was face-down on the floor, Defendant Phillippi and Dorshorst secured his arms and legs.

17. While Plaintiff Lilley was face-down, and his arms and legs were secured, Defendant Matthews began to repeatedly strike Plaintiff Lilley in the torso with his knee.

18. The attack on Plaintiff Lilley was extremely painful, physically and emotionally.

19. The attack on Plaintiff Lilley exacerbated his COPD.

20. Plaintiff Lilley suffered significant mental anguish and distress, which

plagues him to this day and is permanent, as a result of Defendants conduct, as described above.

#### FIRST CLAIM FOR RELIEF AGAINST DEFENDANT DEPUTY MATTHEWS, DEFENDANT DEPUTY PHILLIPPI, AND DEFENDANT LIEUTENANT DORSHORST- EXCESSIVE FORCE

21. Plaintiff realleges and incorporate by reference, all preceding allegations.

22. At all relevant times, the defendant officers were "persons" for purposes of 42 U.S.C. § 1983 and acted under color of state law to deprive Plaintiff Lilley of his constitutional rights.

23. At all times material hereto, the defendant officers used unnecessary,

excessive and deadly force, including but not limited to, attacking Plaintiff Lilley, who was only complying with their orders.

24. The described conduct of the defendant officers, as set forth above, was a cause of the plaintiffs' severe injuries, losses and damages as set forth herein.

25. The Defendant, Wood County, is liable pursuant to Wis. Stat. § 895.46, for payment of any judgment entered against the individual employee defendant in this action because said defendant was acting within the scope of his employment when he committed the acts described above.

#### SECOND CLAIM FOR RELIEF-FAILURE TO INTERVENE AGAINST DEFENDANTS DORSHORST AND PHILLIPPI

26. Plaintiff realleges and incorporates by reference the allegations of all the preceding paragraphs.

27. By the time Defendant Matthews began to repeatedly knee Plaintiff Lilley in the torso, Defendants Dorshorst and Phillippi had effectively secured and arrested Plaintiff Lilley (alebit with excessive force).

28. Before Plaintiff Lilley suffered from the unlawful abuse and excessive use of force described above, the Defendants Dorshorst and Phillippi individually and collectively, had reasonable opportunities to intervene and prevent the injuries and losses Plaintiff Lilley suffered as a result of the unlawful conduct and excessive use of force by Defendant Matthews.

29. As a result of the individual Defendant Officers' failure to intervene, Plaintiff Lilley suffered injuries, losses and damages as set forth herein.

30. The Defendant Wood County is liable pursuant to Wis. Stat. § 895.46 for payment of any judgment entered against the individual employee Defendants in this action because said Defendants were acting within the scope of their employment when they committed the acts described above.

#### THIRD CLAIM FOR RELIEF ~ PUNITIVE DAMAGES

31. Plaintiff realleges and incorporates by reference all the allegations in the preceding paragraphs.

32. That the above-described conduct of all the individual Defendants was unlawful, extreme, malicious, outrageous and/or intentional.

33. That such conduct was intended to cause Plaintiff Lilley unnecessary and severe personal physical and psychological and emotional injuries.

34. That such conduct on the part of all the individual Defendants was a cause of the severe personal injuries, physical and psychological and emotional, suffered by Plaintiff Lilley.

35. At all times material hereto, the individual Defendants acted maliciously and/or with reckless disregard and/or with deliberate indifference towards Plaintiff Lilley or in an intentional disregard of his rights, such as to subject all the individual Defendants to punitive damages.

36. The Defendant Wood County is liable pursuant to Wis. Stat. § 895.46 for payment of any judgment entered against these individual employees defendant in this action because said defendants were acting within the scope of his employment when he committed the acts described above.

WHEREFORE, the Plaintiff demands judgment against the Defendants, jointly and severally, as follows:

a. Against Defendants Matthews, Dorshorst and Phillippi, in their individual capacities, for compensatory damages for the violation of Plaintiff Lilley's rights, as set forth above, in an amount to be determined at a trial of this matter;

b. Against Defendants Matthews, Dorshorst and Phillippi for punitive damages for the violation of Plaintiff Lilley's rights, as set forth above, in an amount to be determined at a trial of this matter;

c. Against Defendant Wood County, for its liability pursuant to Wis. Stat. § 895.46, to indemnify the Defendants in an amount to be determined a trial of this matter;

d. For all costs, disbursements and actual attorneys' fees pursuant to 42 U.S.C.
§ 1988, and for such other relief as this Court deems just and equitable.

#### MONTHLY REPORT TO THE JUDICIAL AND LEGISLATIVE COMMITTEE February 2022

<u>Opioid Settlement</u>. Counsel for the Wisconsin counties had a Zoom meeting with the corporation counsel on January 11 and, after the meeting, shared the attached agenda/presenter's notes for the meeting. I am attaching the document as it very succinctly covers everything that was addressed. The document may be a bit cryptic in places so feel free to ask any questions you have of me. Lance is probably also up to speed on these matters as well. Some key points to the meeting were that: the defendants here have until 2-25-22 to accept or reject the settlement based upon the level of participation; the County would receive its first payment before July if the settlement goes though; the second payment would come in July and the third and subsequent payments would come each July thereafter. Counsel continue to work with other classes of defendants to settle our claims against them.

<u>County Board Supervisor Liability</u>. A couple of members appointed by Wood County to the federated library system board recently asked if either they or the County bore any liability for the actions taken by the library system. I assured them they were not subject to any personal liability unless they took actions like intentionally burning down a library and that because the library system was a separate legal entity, the County had no risk of liability either. These folks then shared with me a power point production presented by the federated library board that seemed to contradict my advice and they asked me to follow up on the issue. I followed up with the person who prepared the presentation and then counsel for the library system and they concurred with my advice as to the liability shield of our appointed representatives. I share this with you now to make clear that absent illegal or wanton conduct, as a county board supervisor you are not subject to personal liability for your actions and inactions on the county board, its committees, or other entities to which you are appointed by the county board. There are always some exceptions, such as open meeting law violations, ethics violations, and so on, but they are the unusual exclusions to the general rule of personal immunity. If you ever have questions about this topic, please let me know.

<u>River Block</u>. Per the long-term lease the County has with Mead-Witter Foundation for use of the land under the River Block building and the adjacent parking lot as well as the County's ownership of the building itself, there was, is, and will be concerns about property tax owing on the various properties. The Foundation had to pay a significant amount in property taxes prior to the County taking control of the properties and just because the County is a governmental entity, we weren't necessarily exempt from these taxes. Any such taxes are the County's obligation under the various agreements. The requisite forms were submitted to the City of Wisconsin Rapids, essentially showing that no private use is being made of any of these properties and so we have avoided any tax obligation. These forms are normally updated every two years but the City's assessor has advised that no updates need to be presented biennially so long as there is no change in use. I have memorialized that communication in my file but thought it was worth mentioning to you folks as a reminder that the County not only doesn't have carte blanche as to how we use River Block, but any change in use could have significant tax implications.

- On 1/4/22, I met with Kayleigh Mengel with the Wood County Health Department to discuss the Community Health Improvement Plan (CHIP) and future workgroups.
- On 1/4/22, I met with Jesse Luer and Megan Birginal with Three Bridges Recovery to learn more about Recovery Coaching and their organization.
- Throughout the month, I attended virtual meetings with three Criminal Justice Coordinators from Eau Claire, Portage and Dunn County to learn about what they do in their role and receive guidance on research and program implementation.
- I attended a SMART Recovery session at the Wood County Jail to observe the group and learn how this program and affected and improved the skills of the participants.
- On 1/14/22, I met with the Chair and Co-Chair of the Judicial and Legislative Committee to discuss expectations for my role as Criminal Justice Coordinator and made proposals for future projects and improvements.
- On 1/14/22, I met with the Department of Corrections to discuss staffing issues, policy updates, Drug Court policies and procedures.
- I met with the Victim/Witness Coordinator to learn more about the effects of Diversion programming on victims, how to collaborate with her department to better assist victims, and to discuss the former restorative justice project.
- On 1/17/22, I attend the National Alliance on Mental Illness (NAMI) Wood/Portage County Board Meeting (virtual) to introduce myself and learn more about their organization, as NAMI plays an important role for mental health treatment courts.
- On 1/18/22, I met with Danielle Luther from Marshfield Clinic to learn about AODA programming and grant opportunities.
- On 1/19/22, I met with David Strong, epidemiologist from the Wood County Health Department to discuss the current research and data regarding justice involved individuals and inmates.
- On 1/20/22, the Drug Court Sustainability Meeting was held and the main topic of discussion was the costs for inpatient treatment and the budget cuts to Wood County Human Services for 2022 in the TAD Grant.

- On 1/21/22, I met with the Finance Department, Brent Vruwink and Bill Clendenning to discuss the 2022 budget. Proposal for carryover made for 2022 by the former Criminal Justice Coordinator did not apply after she left the position (reduction in hours due to educational commitments). I will look to amend the TAD Grant to cover a bulk of these costs, as money was allocated to a trauma group that can no longer be run, as the current Criminal Justice Coordinator is not a licensed counselor.
- On 1/25/22, a meeting was held with Wood County Human Services to discuss the changes to the allocated money from the TAD Grant and the challenges the mental health/AODA counselors were facing due to short staffing and their involvement with Drug Court. Present were: Brandon Vruwink, Mary Solheim, Lance Pliml, Judge Todd Wolf, Bill Clendenning and myself. Wood County Human Services is responsible for paying for inpatient treatment costs for Drug Court Participants, on behalf of Drug Court. In previous years and the current year, \$50,000 was allocated to their department and this amount was reduced to \$25,000 by the previous Criminal Justice Coordinator. In further research, the costs for 2021 for inpatient treatment came to just under \$23,000 and the projected costs for inpatient treatment for 2022 is \$12,000, due to changes with Medicaid. Wood County Human Services agreed that \$25,000 would be sufficient for treatment costs for 2022. Additional grant money is available, should there be additional costs above the current amount. Staffing meetings were also changed from in-person to e-mail communication to save time and efficiency for everyone involved.
- On 1/26/22, I met with Sheriff Becker, Quentin Ellis, and Susanna Knapp to discuss possible funding for Three Bridges Recovery and their programming in the jail for 2022.
- On 1/26/22, a virtual meeting was held with Christina Garcia and Megan Birginal to have an overview of the Americorps Recovery Corps position that was allocated to Wood County. Sara Bristow is working as a Recovery Coach and is supervised by Three Bridges Recovery. Her main roles include working with Drug Court Participants and conducting Smart Recovery Inside Out Programming in the jail twice a week. She also provides additional coaching to jail inmates. They will be requesting that Wood County puts in an application for the next year to be a host site. We will look to work with Danielle Luther from Marshfield Clinic to have their grant fund this position.
- The 4<sup>th</sup> Quarter Fiscal Report for the 2021 TAD Grant was submitted.

#### MEMORANDUM

RE: The Americans with Disabilities Act

The Americans with Disabilities Act (ADA) is a federal law enacted in 1990 that provides a wide range of legal rights to individuals suffering from a disability. Under the ADA, an individual is considered to have a disability if that individual:

- 1. Has a physical or mental impairment which substantially limits one or more of that person's major life activities,
- 2. Has a record of such an impairment, or
- 3. Is regarded by the covered entity (the County) as having such an impairment.

The ADA addresses the requirements of governmental entities as well as private businesses with regard to hiring and firing practices, as well as accessibility to facilities, services, and programs.

The ADA gives certain remedies to those who are victim to a violation of the law. When the violation is deemed intentional, punitive damages are available to the victim as well.

In a 1998 decision by the Wisconsin Court of Appeals, the ADA was construed to allow for personal liability on the agent of an employer who did the discriminating.

In 2008, Congress responded to the narrow construction the federal courts had given to the ADA by enacting the ADA Amendments Act of 2008, known as the ADAAA. In essence, the ADAAA maintained the ADA's technical definition of a disability under the act but vastly expanded what constitutes a major life activity. The 2008 act also expanded when a person's condition substantially limits their major life activities. With the act, conditions that are correctable with prosthetic devices, such as hearing aids, or treatable with medications, still are to be considered a disability if the condition would substantially limit the person's major life activities without treatment.

The ADA does cover both employees and job applicants. So, as an example, a candidate for a position may request an accommodation before arriving for an interview. Also, it is important to know that there are no length of service or tenure requirements to be eligible for coverage under the ADA. Consequently, a new hire who may technically not be eligible for a leave under FMLA, may qualify for a leave under the ADA if they are considered an individual with a disability, as defined by the Act. A leave of absence may be a reasonable accommodation for an individual with a disability when the leave enables the person to return to work following the leave.

The County is obligated under the ADA (which includes the modifications encompassed by the ADAAA) to accommodate persons with disabilities in both the employment and service context unless the cost for doing so will create an undue hardship. This is the standard that employers must evaluate against when determining if they can accommodate ADA requests. Undue hardship is defined differently under the ADA than it is under Title VII of the Civil Rights Act, which covers reasonable accommodate requires for sincerely held religious beliefs. Under the ADA, if the action requested to accommodate requires significant difficulty or expense, it may be denied. Undue burden under the ADA is a higher threshold for the employer to meet when compared to the undue burden definition under Title VII. The concept of undue hardship also arises in the context of applying the Wisconsin Fair Employment Act (WFEA). In construing an employer's obligations under the WFEA, the courts have been very hard on employers by requiring employers to modify actual job duties as well as physical modifications to the workplace. Due to the variances in the laws, it isn't unusual for an employee to cite several laws in complaining about their treatment and the employer is required to comply with all applicable laws.

Reasonable accommodations in the employment sector of the ADA can include changing a workspace to make it more accessible, modifying a work schedule, or providing specialized equipment like desks and chairs. The law requires the employer and employee (or prospective employee) to engage in an "interactive process" to determine what limitations the disabilities will cause and available means of accommodating those limitations. This interactive process can and often does involve the employer seeking additional information and/or posing questions directly to the employee's or applicant's medical provider. This can be a time-intensive process but it is arguably the most important part of the process as it allows the employer to ask for additional information and pose specific questions about the employee's ability to perform the essential functions of the position in order to determine if the County can reasonably accommodate the disability.

The ADA requires employers to keep medical information obtained about an applicant or an employee, including their requests for accommodation, strictly confidential. This information becomes part of an employee's medical file within the Human Resources Department, which is separate from their general personnel file.

As often is the case, the courts have articulated practices that comply with the ADA and those that don't. These court decisions continue to be issued, ergo the law is not static and greater and greater expertise in dealing with the law grows over time. As a result, increased reliance on the Human Resources Department and outside counsel is necessary in dealing with most ADA employment matters.

In the service arena, the standards in building construction and retrofitting buildings also continue to morph over time.

This is just the briefest of primers on the ADA and, of course, this is but one of many laws, state and federal, which deal with protections that employees and prospective employees have been given. Collectively these laws and their constant tweaking by the courts, increase the educational Wood County Board of Supervisors February 15, 2022 Page 3 of 3

requirements of managers and reliance on experts, both internal and external. Therefore, although laws such as the ADA provide benefits to society as a whole, they come at a cost that employers, such as the County, must bear.

13 D. A supervisor may participate in a county board or committee meeting via telephonic or audio-visual means and may vote on those matters presented for consideration. Whenever a roll call vote is taken, each supervisor personally in attendance at the meeting shall be seated and shall be required to vote on the question at issue unless they have properly abstained. A supervisor participating in the meeting via telephonic or audio-visual means shall participate in the vote unless they have properly abstained.

INTENT & SYNOPSIS: To amend County Board Rule #26 so as to grant oversight committees limited authority to transfer budgeted funds within a department.

FISCAL NOTE: None.

**WHEREAS,** current County Board Rule #26 grants the Operations Committee the authority to transfer funds between budgeted functions within a department or to transfer funds from the contingency account if the transfer does not exceed the amount in the contingency account or 10 percent of the funds originally budgeted in the function receiving the transfer, and

WHEREAS, there are times when it would be more efficient for oversight committees to have the authority to transfer funds within a department without going to the Operations Committee or the County Board, and

**WHEREAS**, Wis. Stat. s. 65.90(5) permits a county board to delegate to oversight committees the power to transfer budgeted funds within a department or to transfer funds from the contingency account if the transfer does not exceed the amount in the contingency account or 10 percent of the funds originally budgeted in the function receiving the transfer, and

WHEREAS, the Judicial and Legislative Committee is the 'rules committee' and has discussed the matter and feels that it is appropriate to grant oversight committees the authority allowed by statute to move funds within a department but not to access the contingency account without

approval of the Operations Committee or the county board.

**NOW, THEREFORE, THE WOOD COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES** to amend Wood County Board Rule 26 to read as follows:

#### Rule 26 – Budget Amendments

An amendment to the budget is required any time the actual costs will exceed the budget at the function level. The budget may be amended by a two-thirds vote of the entire county board.

The county board authorizes the Operation Committee, by a majority vote, to transfer funds between budgeted functions within a department or to transfer funds from the contingency account. Such transfers shall be reviewed by the Finance Director and County Clerk prior to the committee meeting and shall not exceed the amount currently in the contingency account or 10 percent of the funds originally budgeted in the function receiving the transfer.

The county board authorizes oversight committees, by a majority vote, to transfer funds between budgeted functions within a department it oversees. Such transfers shall be reviewed by the Finance Director and County Clerk prior to the committee meeting and shall not exceed 10 percent of the funds originally budgeted in the function receiving the transfer.

All budget amendments described herein shall require the publication of a class 1 notice thereof within 10 days of the transfer or amendment.
