The Wood County Land & Water Conservation Department will not consider your application unless you complete and submit all information required by this application form. Nonmetallic mines operating without a permit are subject to penalties as outlined in s. 295.19(3), and ch. NR 135.43(4), Wis. Adm. Code and Wood County Ordinance 802. Please note that the non-refundable plan review fee along with the first year annual permit fee is due at the time of application submittal with **no exceptions**. Faxed reclamation plans will not be accepted.
