## MINUTES OF THE HIGHWAY, INFRASTRUCTURE & RECREATION COMMITTEE

- 1. Call meeting to order. Meeting called to order at 9:00 a.m.
- 2. Declaration of quorum. Quorum declared
- 3. Public comments. None
- 4. Correspondence R. Hawk explained the process of how the Highway Department attempts to recover damages to Highway Department property related to traffic accidents. Highway department program Assistant invoices for the damages giving 30 days to pay. Currently \$20,000 have been recovered through this process. Approximately \$12,000 is outstanding. An account through the Department of Revenue is currently being set up so that the claims that are not paid can be registered and tax returns due to those individuals would be sent to the County instead. A sample letter was shared with the committee. C. Schooley shared that he was invited to a meeting in the Town of Grand Rapids to discuss some water issues related to the Lake Wazeecha area. Prior to C. Schooley's tenure, an agreement was made between the Town of Grand Rapids and the Parks and Forestry Department relating to a ditch on County park property, which was grant funded, and was constructed to help eliminate high water problems in the area. Currently there are high water problems north of the Parks and Forestry owned property, and some from the Town Board believe that the maintenance agreement includes this area of concern. C. Schooley brings this up as it may become an agenda item at some point. B. Clendenning wanted to clarify that the meeting C. Schooley attended was a committee meeting and the request for Parks and Forestry to be responsible for the water problem is only a recommendation from the committee that will be brought to the next Town Board meeting.
- 5. Approve minutes from previous committee meetings. Motion to approve by D. LaFontaine, second by L. Thao. Motion carried
- 6. ATV Trail/Route system update
  - a. Route Updates. R. Hawk explained sign work will not begin until after he knows if CEED money will be granted to the department. If this grant is awarded to the department work could begin as soon as funds were available. J. Hahn inquired if either department was fielding calls about the ordinance change. C. Schooley had one call inquiring about when the routes would be opened. D. Polach inquired how signs were being paid for and if any clubs had offered any assistance. R. Hawk responded that currently grant money and money allocated by the County Board had been used to fund any signs. Two clubs have indicated they may either be able to provide funding or signs. C. Schooley commented that ATV use has evolved over time and originally mainline routes were established for mapping and signage purposes. He questioned if those mainline routes still needed to be marked and mapped. L.Thao understood that signing would be for the routes that are not open to ATV use. R. Hawk indicated that signing would be

done to make it clear to riders what areas are not open to ATV use and that current signing that was found to be not necessary anymore would be removed to help clean up the right of way but this may not happen until work in that area is performed for other purposes. He indicates that there is quite a bit of work to be done and the CEED grant if awarded would incorporate taking down and putting up of signs.

b. Ordinance Updates. None

#### 7. HIGHWAY

- a. Highway staff reports. R. Hawk informed the committee that the Truck Operator position that he requested permission to hire for has been filled and he will start on August 16<sup>th</sup>. One mechanic gave his resignation and after talking with Human Resources was offered and accepted a casual position. He would earn one wage as a mechanic and a different wage if he came in as a truck operator. Another mechanic turned in his resignation this week to work for Nine Dragons for a much higher rate of pay. R. Hawk met with the Village of Biron property owners about CTH U between the Eagle Road segment that was completed last year and the Bridgewater Development to discuss making improvements to this section including adding a multi-use path. Three options were discussed but the most popular option was to abandon a portion of the road and turn the area into a multi-use path. Stewardship funds could be used to build the path. Huffman Rd in the Village of Biron is in rough shape and would have increased usage if CTH U was discontinued. The Highway Department could help the Village rebuild this road. After work was complete R. Hawk's recommendation would be to turn the remaining sections of CTH U located in the Village over to them. STP rural and STP urban grant money would be applied for to help pay for these costs. R. Hawk would like approval to purchase new survey equipment from Leica Geo Systems. An estimate came in at about \$26,000 to purchase the GPS Rover this includes a 20% discount. Topcon is not supporting us in the way we need to be supported with our current survey equipment. The used equipment could be sold for \$12,000. In the future R. Hawk would look to add a base station at a cost of \$17000. The department currently has the funds to pay for the rover it in the 2021 CIP for equipment. Motion to approve the purchase of the GPS Rover by D. LaFontaine, second by J. Hokamp. J. Hahn inquired if the base would be installed on a tower at Powers Bluff. R. Hawk indicates that would not be recommended because of little to no ability to monitor it. The recommendation would be to mount it on the Wisconsin Rapids Shop. Motion Carried
- b. Highway revenue report
- c. Highway vouchers. Motion to approve by A. Breu, second by J. Hokamp. Motion carried.
- d. CIP. J. Hahn states that chairs of committees were asked to take a closer look at budgets. At this time it does not look like any cuts can be made. R. Hawk states that there is a surplus in local bridge and road programs. A reduction in both of those programs was offered last year. He does not recommend a reduction in the bridge program this year as we pay for half of bridges that qualify no matter the cost and he is aware that several will be replaced next year. R. Hawk would offer to give back \$50,000 out of the road program with the understanding that funding would need to continue or both of the program funds will become depleted. The 2022 bond amount requested of 2.5 million if cut would cause matching funds to disappear and grant money and reimbursements will cover more than half of the cost of the projects. The CIP for equipment does not come from bonding or from the Levy but instead from charging projects for the equipment used. J. Hahn cannot see how we can be reduced without risking the additional funding. Motion to reduce the amount of the levy for the local road program by A. Breu, second by L. Thao. Motion carried.
- e. Request for hire Mechanic. Two mechanic positions are open at this time. R. Hawk is looking for permission to hire. **Motion by J. Hokamp, second by L. Thao. Discussion:** A. Breu states something needs to be done with the wage. R. Hawk indicates that young people are chasing the dollars. R. hawk would like to find other heavy equipment mechanics in our area make a comparison to what is being offered to County mechanics. Some of the problems in recruiting them is the cost of tools we require. An average mechanic has \$60,000 \$100,000 in tools and

- the county only reimburses them \$300 per year and they are required to come with the tools required. **Motion Carried**
- f. Bridge Polymer Overlays. R. Hawk informed the committee that an advertisement for bids for bridge polymer overlays went out for several fairly new bridges and are due back by August 18<sup>th</sup>. If the bids were not accepted until the September meeting it would not give the contractors enough time to complete the work before the weather starts getting cooler. R. Hawk only knows of two contractors in the area that do this work. R. Hawk would like to open the bids and offer the lowest bidder the project if the bid comes in within the budgeted amount of \$100,000. **Motion by D. LaFontain, second by J. Hokamp. Motion carried.**
- g. Shop truck. R. Hawk would like permission to purchase a new shop truck from Stellar Industries without bidding it out. The Highway Shop Superintendent has been in communication with Portage County about the shop truck they bid. The bid price they got is about the same as the quoted price from Stellar. This truck would reduce the amount and cost of down time by being able to provide roadside repair to hydraulic hoses and would come equipped with a crane to reduce towing costs that average about \$300 each time. In trying to keep engines uniform the shop truck would be equipped with a Cummings engine so this limits us to a Dodge 5000. The truck is in the 2021 CIP. R. Hawk would like permission to order from Stellar Industries.

  Motion by A. Breu, second by D. LaFontaine. J. Hahn agrees that it is the right way to go.

  Motion carried.
- h. Recognize National Rail Safety Week. Motion to recognize Nation Rail Safety Week by A. Breu, second by D. LaFontaine. Motion Carried.

#### 8. PARKS AND FORESTRY

- a. Parks & Forestry staff reports. C. Schooley discussed the condition of the Powers Bluff shelter basement and the proposal for a remodel. Currently the basement has an employee lounge, concession area, general area, overflow storage and wood storage rooms. The basement is currently heated by two wood stoves. A new concessionaire came in last year and has been doing a great job. Heath inspectors came in and found issues in the concession area. The baseboard is rotting out and some surfaces are not easily cleanable. C. Schooley would also like to get away from the wood heat for safety reasons and for ease of use. C. Schooley is proposing a remodel of the basement that would include installing a forced air unit in the basement and a ceiling mounted LP unit, removing the walls for the overflow and wood storage rooms, and taking down all the walls in the concession area and starting fresh. C. Schooley would like to get this project started by mid-August. Furnaces will cost about \$12,000. A LP tank is already on the property and can be reused. Funds are sufficient in the HoChunk fund because not as many trails have been improved this season for various reasons. Motion by D. LaFontaine, Second by L. Thao. Discussion: D. LaFontaine recommends a thermostat that can be controlled remotely. J. Hahn believes you have to have Wi-Fi. C Schooley working with communications to get Wi-Fi at Powers Bluff. Motion carried.
  - C. Schooley states that the State water ski show was a huge success. C Schooley wants the committee to know what his staff have into the event. In total there were approximately 65 working hours with full time and seasonal staff for set-up, during the event and clean-up. A variety of equipment was use for a total of 28 hours. Labor costs were \$1,500 and equipment costs were \$800. D. Lafontaine inquired what the economic impact of the event was. C. Schooley states that he does not have data from this year but past studies have shown it to be in excess of \$1.5 million. That estimate is from several years ago and this year's show was very heavily attended, so C. Schooley would speculate is was over \$2 million this year. The department collects a premium for camping fees during ski show week. Camp sites are required to be reserved for the entire show period and the sites cost more during that time. Fees are charged to the Aqua Skiers for the use of shelters. C. Schooley wants to stress that this is information only. B. Clendenning states that the Grand Rapids staff put in a lot hours and many people volunteers. C. Schooley wants to remind the committee that there was an error in this year's budget that caused the levy to be reduced and when the new budget comes out he will be

- requesting the 2.5% increase on the amount it should have been this year. F. Scubert states there is a minor change since he wrote his report. Site prep contractor got back to him and won't be able to do some of the work requested so it will be pushed back to next year.
- b. Special Use permits. 1. 1<sup>st</sup> Choice Pregnancy Center walk is an annual event fundraiser that will use the trail around Lake Wazeecha and the enclosed shelter. **Motion by D. LaFontaine, second by J. Hokamp. Motion carried.** 2. Annual request by the Multi-Metro deer management group to harvest antlerless deer in a restricted area of South Park. This event had been held for many years and there has never been a problem. **Motion by D. LaFontaine, second by A. Breu. Motion carried.**
- c. CIP. Operations committee has asked committee chairs to look and see if reductions can be made. C. Schooley indicates that the total is not all debt service, \$80,000 comes from the levy and \$370,000 would be coming from debt service. The Dexter wood shed would be eliminated because funds from this year are being used and project is already underway. Parks has already been notified that they will not receive the grant for the storm shelter at South Park so that project can be eliminated. Grants were also written for the Dexter beach house and the Powers Bluff entrance road. If these grants are not received these projects would not be done. At this time C. Schooley is looking for \$350,000 from county borrowing and \$80,000 from tax levy outlay. Motion to send the request for \$350,000 to the operations committee by J. Hahn, second by L. Thao. Motion carried.
- d. C. Schooley presented a proposal for changes to LTE positions for 2022 to help with recruitment and retention. C. Schooley checked with HR to see if we could extend the potential pool to include 16 and 17 year olds. They are limited in the duties they could perform so C. Schooley proposes the following: 1. Create an LTE I position for those 16 or 17 that would have a more limited job description. Pay range would be \$11-\$12/hr. with \$.50 increases for returning, once they reached 18 they would could move to an LTE II position. 2. Increase the wage range from \$11-\$13/ hour for LTE II to \$12-\$15/hour with \$.50 increased for returning. 3. Increase camp ranger rate from \$10-\$11/hour to \$12-\$14/hour with \$.50 increases for returning, they also get overtime after 40 hours. 4. Allow flexibility in hiring at a higher rate or increase wage based on performance. 5. Hire more LTE staff to allow for reduced hours for those that do not want to work a full time schedule or do not want to be working so many weekends. Parks could also use more staff in the summer to maintain with the increase in use. J. Hahn would like to table until after the budget meeting. D. LaFontaine is in favor with flexibility in wages because of the recruitment issues. J. Hokamp wondered if there a probationary period at this time and there is not one F. Shubert indicates that the trend for park use is increasing so more money is being made with less staff. D. LaFontaine asked if a rover would be possible in the LTE positions to cover for when others are gone. C. Schooley indicates it could be a possibility.
- e. 2022 Parks and Forestry Fees C. Schooley recommending increases in most fees. He compared fees to adjoining counties and based his increase on those numbers. Some of these fees have not been increased in quite some time. J. Hokamp believes that electric at the water front should be increased to \$30. C. Schooley did an across the board \$2 increase on all camping nightly fees. **Motion to approve by J. Hahn, second by L. Thao**. C. Schooley states that when new system for reservations is up and running and can handle having two separate fees that is when the fees will be implemented. **Motion carried**
- f. Wood County Forest Comprehensive Land Use Plan: Draft Chapters, 3000, 4000, Glossary, Discussion of Public Meeting, 30-Day Comment Period, Final Approval Process. F. Schubert indicates that the plan is at the end of its drafting stage. The end of process would be to have an open meeting on August 30th 6-9 pm at the Nepco shelter. He would like to start the 30 day comment period tomorrow. Then send off to DNR for their review. Any modifications would be brought back to the committee. Fritz would be leading the public meeting. Previous one was not well attended.

- g. Parks and Forestry revenue reports F. Schubert indicates that 2 timber sales have started recently. If weather and markets hold we should be on track to meet budgeted 2021 timber revenue.
- h. Parks & Forestry vouchers **Motion to approve by D. LaFontain, second by L. Thao. Motion carried.**
- 9. Future Agenda Items. R. Hawk states that we currently do not have a work in the right-of-way permit. A proposed permit has been created and will be on the agenda for approval at the next meeting. Property owners that want to do work in the right of way would pay \$50 fee with a \$300 refundable deposit upon satisfactory completion of the work. This permit falls in line with access control ordinance. R. Hawk would also like to propose and after the fact fee of \$400 that would be non-refundable. B. Clendenning asked if that included cutting trees. This permit would cover those that request to do that. A. Breu asked if \$300 is enough to cover costs if the County has to fix something. R. Hawk indicates that most of the time it would be but the permit does authorize more to be charged if the cost went over the \$300. If anything else needs to be added get a hold of Jake, Roland or Chad.

- 1. Call meeting to order. Meeting called to order at 9:03 a.m.
- 2. Declaration of Quorum. Declared
- 3. Public comments. None
- 4. Review of both Parks and Highway draft 2022 budgets and recommendation to forward to the Operations Committee for further review.

**PARKS** - C. Schooley presented the Parks and Forestry budget. C. Schooley began by reminding the HIRC of a clerical error that was made in the 2021 budget that effected the tax levy for this year. He handed out the draft budget that was approved by HIRC in 2021, which was then forwarded to the Finance Department, and the Operations Committee. After the Finance Department instructed departments to try to find additional budget reductions, P&F agreed to make adjustments by reducing its 2021 CIP, and by increasing 2020 revenue estimates. However, in error, the 2021 revenues were increased instead of 2020 revenue estimates, thus reducing the 2021 levy amount. For this reason, C. Schooley would like the HIRC, and Operations Committee to base the 2.5% departmental budget increases off of 2020 tax levy totals instead of 2021 tax levy totals. C. Schooley presented the 2022 budget summary. The only tax levy account is the 2101 account. Tax levy request is \$724,907. All other functions are nonlapsing accounts and are funded through grants and/or fund balance. C. Schooley highlighted the increases for the year. Revenue was increased due to increased park use and the approval of user fee increases for 2022. Increased expenses are mostly from the increase in wages and the three new LTE 1 positions that would be created. There is an increase in workers comp. Professional services increased because more firewood is being processed. Liability insurance increase and is somewhat out of our control. An increase of \$40,000 for capital outlay. The rest of the accounts are not tax levy and are funded tough other sources such as grants. Snowmobile trails is money in from DNR and money out to clubs, except bridges which are grant funded a little differently. ATV trail maintenance is grant funded through the DNR. The ATV intensive use area funding comes from DNR grants and club donations of inkind work. Parks capital projects account is for future CIP projects. L.Thao wanted to know why the signing of ATV routes on roadways was not in the Parks and Forestry budget. J. Hahn replied that the signing of roads had been moved to the Highway Department budget. D. Polach question the State Wildlife Habitat fund as it was higher last year. C. Schooley will look into it. J. Hahn made a motion to approve the budget as presented, second by A. Breu. Motion carries.

**HIGHWAY** - J. Peckham presented the summary of the Highway Department Budget. The operations committee asked for cuts last year and the Highway Department gave back \$53,571 out of the County Road-Aid Fund and \$100,000 out of the County Bridge-Aid Fund. For the 2022 budget year the Department is asking for the return of the \$53,571 for the Road-Aid Fund and \$50,000 of the \$100,000

for the Bridge-Aid Fund. J. Hahn commented that those funds were given back with the understanding it was for one year and would come back to the department. The budget narrative shows a comparison of this year to next year and would have comments on anything that had an increase of 10% or over the 2021 budget. D. LaFontaine commented that some had some big percent changes but were small numbers. J. Hahn, would like a separate line item for the ATV sign maintenance. CEED has preliminary approved a grant for \$20,000 to help with the signing the other \$20,000 will need to come from the Highway Department budget. J. Hahn indicates that some ATV clubs have reached out to the Highway Department and offered assistance with signing. This may be inkind or monetary donations. B. Clendenning doesn't think there are any clubs in Wood County, J. Hahn knows of two active clubs and believes that as more roads and trails become available more clubs will form. Motion to approve the Highway Department budget with the addition of the \$20,000 expense for ATV signs made by D. LaFontaine, 2<sup>nd</sup> by L. Thao. Discussion J. Hahn doesn't believe the Highway Department CIP should be cut and needs to be maintained at the \$2.5 million for the future. Motion carries.

5. Motion to adjourn. J. Hahn adjourned the meeting at 9:43.

Subject: Commissioner Report for September 1, 2021 HIRC meeting

#### **Department Activities**

#### **Personnel**

New truck operator interviewed in July started August 16. Interviewed two candidates for two mechanic vacancies. Made an offer to one candidate who accepted, working with HR to schedule additional interviews for second opening.

Commissioner and management staff are developing a procedure for patrolman when responding to incidents similar to the one in Clark County where one person was killed and the second severely injured.

#### Highway/Facility Projects

CTH BB (US 10 – CTH B) paving was completed July 28, using recycled asphalt for shouldering material. Crews started shouldering in early August but due to higher priorities, approximately 1/3 of the shoulder material has been installed. The road is open to local traffic and crews will continue shouldering on rainy days or as paving demands diminish.

Work on CTH N bridges (2) (CTH F – CTH S) started June 15. The contractor has completed the east bridge and due to heavy rains and high water in late July, the west bridge is anticipated to be completed by September 9. County crews began pavement work August 23 with anticipated completion September 17.

Work at the Marshfield site to construct a State & a County salt shed is going very well. The State salt shed foundation is complete and much of the walls have been constructed. The foundation for the County shed is nearly complete. The State shed is still on scheduled for a late October completion. The County shed is on track for a mid-November completion. The City of Marshfield building inspector was not happy with the late payment for the building permit. Due to the process to request checks for payment the payment was not received prior to starting work. Issue has been resolved.

Highway & City of Marshfield staff met with the Architect conducting the shared campus study at the Marshfield facility. A third meeting was held August 30. A combined meeting with HIRC and City alderman will be scheduled soon, to share the findings.

Engineering work on CTH U corridor from South Biron Drive to Huffman Road continues. Commissioner met with Ho-Chunk BIA Roads Staff to confirm grants on CTH X project slated for 2022 and CTH Z project slated for 2024.

Highway staff have developed a Work in The Right of Way permit for various tasks that does not fall under either the Utility Permit or Access Permit. Commissioner is seeking permission to implement the Work in the R/W permit and add "After the Fact" fee to the Access Permit.

#### Highway Maintenance

GSB 88 work was completed in July on CTH C west of Vesper, CTH AA south of Nekoosa, CTH P in Milladore. The first round of R/W mowing was completed the week of July 19.

Crews have been installing new culverts on CTH F between CTH HH – CTH P for the 2022 pavement replacement project as well as replacing failing culverts on CTH E between Arpin and US 10. Crews have also installed culverts in numerous towns in July.

Crews have been working on installing a detention pond at the Marshfield Highway facility as required in the site plan approved by WDNR. A site plan was required as part of the construction plans for the new salt sheds.

#### ATV Plan/Development

Commissioner continues to have ongoing communications with ATV/UTV clubs and riders regarding the Ordinance change and when county highways will be opened. Commissioner attended the CEED committee July 18 to promote the request for \$40,000 to complete the ATV/UTV plan. The committee voted to approve \$20,000.

#### **Engineering Equipment**

Engineering staff are working on the purchase of new survey equipment as approved by the HIRC. Instead of pursuing a stationary base station, the vendor has identified a subscription to SmartFix, Leica's reference system with reference stations already established in Wood County and neighboring counties. Using the SmartFix reference system avoids having the highway department install and maintain base stations.

#### **Shop Equipment**

The engineer hit a deer with his county vehicle, (2013 Ford Explorer with 160,878 miles). The estimated damage is \$8,000. The vehicle is valued of \$10,000. Shop is pursuing options to use damage payment to replace the vehicle. Commissioner is looking for permission to solicit local dealers for half ton truck quotes and purchase a replacement vehicle.

The 2021 patrol truck chassis will be delivered in the next 60 days and then the box, special tailgate and brine system will be built and installed. The expected in service date is late December to early January.

## **Accounting Supervisor Report**

Revenues are as anticipated. We have been working on several Road Aid and Bridge Aid projects so the revenue will be booked as those projects get completed. Asphalt revenues continue to come in as we run the plant full-time. Revenues from the State are on target.

## **Parks & Forestry Department Reports**

Thursday, September 2, 2021

#### **Director Report, by Chad Schooley**

- Continue assisting with new P&F reservation system development process. We are currently researching the option of going "Reservation Only" at our campgrounds starting next year. This would require individuals to call the office or go online to make reservations at the park. This would provide for "same day" reservations, which would be a change from the current "7 day in advance" requirement. This would also eliminate the current "self registration" at the campground where individuals can pay with cash/check at the registration station.
- Over the past several years we have had issues with geese in our parks, particularly in our beach
  areas. I have once again reached out to representatives from USDA-APHIS regarding options we
  have with population control. I would like to have a representative come to a future meeting to
  discuss this subject.
- Continue work on 2022 budget. The budget that was approved by the HIRC at the last meeting did
  not include my recommendations, which I presented at the August 5 meeting, regarding
  increasing the hourly pay range for LTE's. Chairman Hahn asked me to bring this back for
  discussion and possible approval. I will bring information showing the financial impact the
  changes would have on our budget.
- We have started the process of purchasing and installing security cameras at our South Wood
  County Park. The 4 camera system was installed at the Red Sands Beach Pavilion. Future install
  locations will be White Sands Beach House, Nepco shelter building, and the South Park Ranger
  station. Installation timeframe will depend on finding funding sources. The 1st install was done
  using P&F operations budget and was approximately \$3,000.00.
- Filled in for Chairman Pliml on his monthly radio show for WDLB on August 20th.

#### Construction Supervisor Report, by Dennis Quinnell

#### **Construction Projects**

- Plans are being made for a small storage building at the South Park Campground.
- Quote accepted for the concrete portion of the firewood storage building at Dexter Campground.
- Quote has been accepted for the installation of the furnaces in the Powers Bluff Shelter basement.
- We are beginning the remodel of the lower level of the Powers Bluff Shelter.

- Updated website, Travel Wisconsin, Facebook and Instagram with pertinent news.
- It continues to be extremely busy in the office with camping and shelter inquiries.
- Issued and processed violations within our parks.
- Attended a WebEx meeting with the Konect vendor, IT and our office to launch our new reservation system. We received information on what the layout will look like and we were all very impressed with the simplicity of it.
- Continued budget preparation for 2021-2022 in Questica. Chad and I worked with Finance on various issues.
- Assisted Chad in new fee structure for 2022 that was recently approved by HIRC. Will begin updating various brochures with the newly implemented fees.
- Attended the 2021 Summer Employee meeting at North Park and recorded minutes.
- 15-yr. Forestry Plan. Uploaded newly drafted chapters to the Forestry website and made 3 paper copies for people to view if they wish.
- Attended the August 18th Special HIRC Budget meeting via WebEx.
- Attended the Boston Mutual Presentation by HR on 8/24 at 11am.

## Forest Administrator Report, by Fritz Schubert

- Timber Sales: Currently 3 active timber sales. Met logging crews and started jobs, scaled wood, job site inspections, routine timber sale administration. Closed ATV intensive use area for two days to facilitate safe logging operations (sale #786) adjacent to trail.
- Wood County Forest 15-year plan: sent letters to stakeholders and drafted announcements pertaining to 30 day comment period and open house meeting. 30 day public comment period ends September 6, 2021. Open house meeting occurred August 30, 2021.
- Forestry Tech. has been working on project to construct/improve Powers Bluff multi-use trail.
- Forestry Tech. mowed selected forest roads and trails as equipment availability and weather permitted.
- Mowed and cleaned up public shooting range.
- Participated in WCFA quarterly administrators conference call.
- Attended LIDAR presentation put on by Paul Bernard (P&Z) and others.
- Attended P&F employee meeting on 8-19-21.

#### Proposed LTE Changes to Improve Recruitment and Retention in 2022

- 1) Create an LTE I position that will allow us to hire 16 and 17 year olds. Job Descriptions would be specific so that driving large equipment, operating chainsaws, brush saws, etc... would not be allowed. Main job duties would include cleaning facilities, picking up litter, and assisting FTE's in other maintenance jobs. Proposed pay \$11-\$12 (.50/hr increase for returning employees)
- 2) Increase LTE II rate from current \$11-\$13, to \$12-\$15. ( .50/hr increase for returning employees.
- 3) Increase Camp Ranger rate from current \$10-\$11 to \$12-\$14, (with .50/hr increase for returning employees.
- 4) Allow Department Head to use current Recruitment and Retention Policy to hire at a higher rate than starting wage, and/or advance employees by skipping a step, based on experience and performance
- 5) Hire additional LTE staff to allow for more flexibility in scheduling. It has become difficult attracting seasonal employees who want to work a full 40 hour week. This would also reduce the number of weekends each LTE has to work in the summer, which is another complaint we have heard from applicants.
